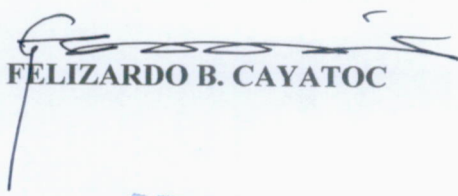
Respectfully forwarded is the memorandum of CENRO Roxas, Palawan dated January 05, 2023 relative the above subject.

Per memorandum, the apprehension was made on July 23, 2022 at around 06:37 P.M. by the Monitoring and Enforcement personnel of CENRO Roxas while waiting for the go-signal from their informant relative to the alleged illegal transport of undocumented forest products. They received a call that Bantay Roxas Tasked Force (BRTF) has intercepted one (1) unit topdown loaded with Rattan Poles along the National Highway of Brgy. Magara, Roxas, Palawan.

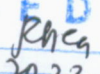
The apprehended items have the estimated fair market value of Php9,120.00 for the six (6) bundles of Rattan Poles and Php90,000.00 for the One (1) unit topdown. The apprehended items were brought to CENRO Roxas compound for safekeeping purposes under the custody of Forest Technician II, April N. Baltar.

Two (2) Notices of Hearing were sent to all concerned parties specifically dated on August 3, 2022 and August 17, 2022 for the scheduled hearing on August 10, 2022 and August 23, 2022 respectively in relation to Section 7 volume of DAO 1997-32.

We concur with CENRO recommendation for the forfeiture of the 6 bundles of Rattan Poles with equivalent volume of 4,560 linear meters and one (1) unit topdown tricycle powered by BARAKO 175CC with Engine No. BO175A-L545410 in favor of the government and institution of the appropriate legal sanction against the offender in the proper court.

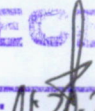

Submitted herewith is the summary of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32.

I. FACTS OF THE CASE

The apprehension was made by the DENR CENRO MES personnel on July 23, 2022 while waiting for the go-signal from their informant relative to the alleged illegal transport of undocumented forest products they received a call that Bantay Roxas Tasked Force has intercepted one (1) unit topdown loaded with Rattan poles along the National Highway of Barangay Magara, Roxas, Palawan. The apprehended forest products and conveyance were brought to this Office compound for safekeeping under the custody of Forest Technician II April N. Baltar.

II. NOTICE OF HEARING

Pursuant to the provisions of the Department Administrative Order No. 97-32 Re: Rules of Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 07, Item No. 01, issuance of Notice of Hearing for the conduct of administrative

proceedings. Further, Notice of Hearing was issued and was scheduled on August 10, 2022 and August 23, 2022.

III. EVALUATION

The respondents failed to attend the first administrative hearing due to the passing of Mr. Pielago's father.

The 2nd administrative hearing was attended by Mr. Ronilo Pielago and Mrs. Concepcion Pielago.

During the administrative hearing, Mr. Pielago stated that, they went to Barangay Caruray, San Vicente, Palawan to get Rattan Poles near the warehouse of Ms. Elsie Torres however, accordingly, they failed to ask permission from the owner. He further stated that before pandemic they have proper documents with the concessionaire but failed to renew the said permits when it expired. Also, he admitted that during their transport of the forest products, they did not possess any permits from the DENR and admitted that they did not have permission from the P.O. President Ms. Elsie Torres of Caruray Agricultural Marketing Association (CAMA). He said that they were able to buy the Rattan poles from someone in the area but did not disclosed the identity of the person who sold the rattan poles since upon arrival at the buying place, the forest product were already piled along the road and they immediately loaded it on their top down tricycle and handed over the money to the seller without asking his name.

Furthermore, during the hearing, it was revealed that spouses Mr. Ronilo Pielago and Mrs. Concepcion Pielago has been in Rattan furniture business since year 2000 and sourced out their rattan poles from different concessionaires. Thus, they are very much aware on the requirements prior to transporting rattan.

IV. RECOMMENDATION

Henceforth, recommending that the six (6) bundles of Rattan Poles (Sik-sik) with equivalent volume of 4,560 linear meter and the one (1) unit top down tricycle powered by BARAKO 175 with Engine No. BO1175A-L545410 be forfeited in favor of the government and the institution of the appropriate legal sanction against the offender in the proper court.

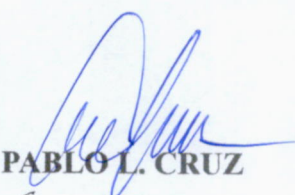

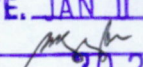

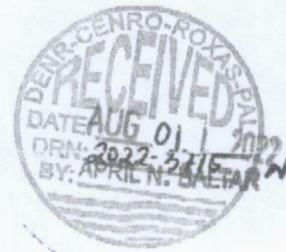

Please be informed that in the morning of July 23, 2022 Forest Ranger Charlie Rabang received an information from a concern citizen that there will an illegal transport of undocumented forest products in Barangay Caramay, Roxas, Palawan in the evening of the same day. Forester I Marces C. Lasangen, In-Charge of MES formed a team to conduct surveillance and operation against illegal environmental activity.

Around 6:20 P.M., while on standby at Barangay Magara, Roxas, Palawan waiting for the go signal of the informant in the area, Forest Ranger Rabang called and informed Forest Ranger James S. Tajon, Team Leader, that the said operation was cancelled. While the team was preparing to return to CENR Office, the team received another call from FR Rabang saying that the Bantay Roxas Task Force have intercepted one (1) unit of topdown tricycle loaded with rattan along the National Road of Barangay Magara, Roxas, Palawan.

The team proceed to the area and found the said conveyance powered by Barako 175 loaded with six (6) bundles of rattan poles (siksik). Upon investigation, the driver and owner of the intercepted conveyance was Mr. Ronilo G. Pielago, FR Tajon then asked him to present his permit pertaining to the legality of his transport of the said forest products but failed to do so. Upon failing to present the required permits, Mr. Pielago was apprehended for violation of Section 77 of Presidential Decree No. 705, as amended by R.A. 7161, then Miranda Rights was read to the latter to inform him of his rights. Then, he was asked to come with the undersigned to the CENR Office for further documentation which he immediately complied.

Further, the apprehended conveyance and forest products were deposited to the DENR CENR Office compound for safekeeping
