Please be informed that two (2) personnel of this Office, namely Forest Technician II Jackielou P. Dumlao and Forest Ranger Jennalyn H. Francisco were accidentally wounded/injured due to a lone vehicular accident last February 7, 2023 while in the performance of their official duties, to wit:

- 1. That on February 7, 2023 FT II Dumlao is in the ENGP Forest Nursery located in Barangay Batasan, San Jose Occidental Mindoro, monitoring the construction of the nursery bunkhouse under Travel Order #192;
- 2. That on February 7, 2023 FR Francisco is with her supervisor, Forester I Alexis Joy D. Belarmino NGP Coordinator concurrent Head, Forestry and Wildlife Utilization, conducting tree inventory in Barangay Murtha, San Jose, Occidental Mindoro under Travel Order # 193;
- 3. That after the inventory (around 12:00 NN) Forester Belarmino and FR Francisco visited the nursery to supervise the activities of NGP Staff including FT II Dumlao;
- 4. That FT Dumlao was informed of the need to purchase nails and replace the existing sheet file with the correct size, for immediate use on the bunkhouse construction;
- 5. That at around 5:10 PM, FT Dumlao and FR Francisco proceeded to purchase nails and sheet file for chainsaw. They were instructed to purchase it at the nearby supplies and hardware store in Barangay Murtha, San Jose, Occidental Mindoro;
- 6. That on the said personnel's travel back to the Nursery, a stray dog suddenly appeared and crossed the road on its upward slope which resulted to their accident and caused them major physical injuries and psychological trauma.

Relative to this, respectfully requesting your good office to grant the approval of the aforementioned personnel's rehabilitation leave to undergo to rest, medication and recuperation as per instruction of their attending physician. 
