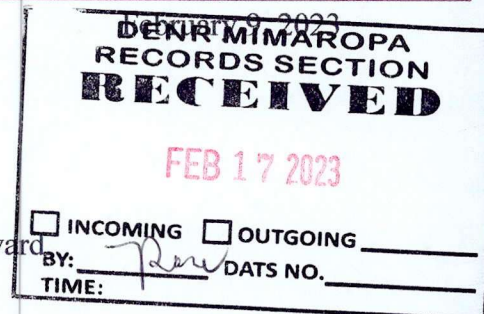

A RESOLUTION AUTHORIZING IPMR ARNEL P. ABRINA TO REPRESENT THE INDIGENOUS PEOPLES IN THE EL NIDO-TAYTAY MANAGED RESOURCE PROTECTED AREA (ENTMRPA) – PROTECTED AREA MANAGEMENT BOARD.

Resolution No. 2022-003
Authored by: Council of elders and IPMRs

WHEREAS, that Section 17, Article XIV of the 1987 Philippine Constitution provides that the State shall recognize, respect and protect the rights of ICCs/Ips to preserve and develop their cultures, traditions and institutions. It shall consider these rights in the formulation of national plans and policies;

WHEREAS, that Section 16 of R.A. 8371 states that ICCs/Ips have the rights to participate fully, if they so choose, at all levels of decision-making in matters which may affect their rights, lives and destinies through procedure determined by them as well as to maintain and develop their own indigenous political structures. Consequently, the State shall ensure that the ICCs/Ips shall be given mandatory representation in policy-making bodies and other local legislative councils;

WHEREAS, that the term of our Municipal Indigenous Peoples Mandatory Representative has ended last December 31, 2022;

WHEREAS, vacuum in the position of Municipal Indigenous Peoples Mandatory Representative must be avoided in order to ensure that ICCs/IPs shall be given equal rights, opportunities and mandatory representation;

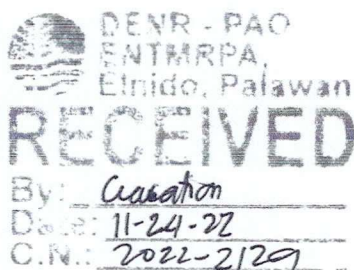
WHEREAS, that during the meeting on July 11, 2022 of all leaders of different tribes in El Nido, the Cuyonen Tribe, Tagbanua Tandulanen Tribe, Agutaynen Tribe and Tagbanua Calamianen Tribe, together with the CSC of Roxas, NCIP Provincial Office, Regional and Central Office in the presence of NCIP Chairperson Allen Capuyan, have agreed that the next Municipal Indigenous Peoples Mandatory Representative in the Municipality of El Nido shall come from the tribe of Cuyonon;

WHEREAS, that Indigenous People shall exercise mandatory representation in the El Nido-Taytay Managed Resource Protected Area (ENTMRPA) – Protected Area Management Board (PAMB);

NOW THEREFORE, on motion of IPMR Liza Baldivia and duly seconded by IPMR Anacleto Gustilo Jr. be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize IPMR Arnel P. Abrina to represent the Indigenous People in the El Nido-Taytay Managed Resource Protected Area (ENTMRPA) – Protected Area Management Board;

RESOLVED FINALLY, that a copy of this Resolution be furnished the Office of the ENTMRPA-PAMB for proper information.
