Attached herewith as **Annex "A"** IAC Resolution No. 9-2021 dated July 15, 2021 which stated and resolved the following:

Be it resolved, as this Body hereby resolves in its meeting duly assembled on July 15, 2021 "to exclude Lumintao River from the list of rivers for the dredging activities in the Province of Occidental Mindoro to be evaluated by the IAC in view of the DPWH Dredging Clearance and approved Dredging Plan issued to Bluemax Tradelink Inc. in 2018 or prior to the issuance of DENR Administrative Order No. 2020-12. Also, Bluemax Tradelink Inc. has already been undertaking desilting activities in Lumintao River, Rizal, Occidental Mindoro and has a Memorandum of Agreement with the Provincial Government of Occidental Mindoro prior to the issuance of the above Administrative Order. Therefore, Bluemax Tradelink Inc. may commence with the implementation of large scale dredging operation in Lumintao River, subject to the issuance of an Environmental Compliance Certificate (ECC) by the EMB."

The said Resolution stated that Lumintao River has been excluded from the list of rivers to undergo evaluation by the IAC which is applicable only for new applicants, the IAC concluded that Bluemax may commence with the implementation of large scale dredging operation subject to the issuance of ECC.

On May 26, 2022, attached **as Annex "B"**, we have furnished your good office copy of large scale ECC of Bluemax for Dredging / Desilting issued on May 24, 2022 by EMB pursuant to DAO 2020-12 and in compliance with the condition of the said resolution.

On the offshore issue raised by Bluemax, is a general concern of all proponents, letter has been sent to your office received on Oct 13, 2022, attached as **Annex "C"**, which IAC has discussed / resolved in a meeting on August 15, 2022 is in consistent with Section 2 of DAO 2020-12 resolved by IAC Resolution 17-2022 being circulated to the IAC members for signature.

Having complied the above, we humbly seek your support and guidance as we coordinate our implementation of large scale dredging operation.



RESOLUTION NO. 09 Series of 2021

WHEREAS, the Department of Environment and Natural Resources (DENR) issued DENR Administrative Order No. 2020-12 with the subject of Rationalizing Dredging Activities in Heavily-Silted River Channels within the Province of Occidental Mindoro pursuant to the DENR-DPWH-DILG-DOTC Joint Memorandum Circular No. 1 Series of 2019;

WHEREAS, Section 2 (c) Title VII of the above-mentioned Administrative Order states that "The inter-agency committee shall have the following powers and functions: b. Shall propose policies and programs to rationalize the dredging operations."

WHEREAS, to provide immediate and adequate assistance to our countrymen affected by floods due to the heavily-silted river systems in the Province of Occidental Mindoro, it becomes imperative for this Body to issue resolutions that will create an operating structure for dredging operations in said province;

NOW THEREFORE, on motion of MGB Regional Director Glenn Marcelo C. Noble, duly seconded by other members present, BE IT RESOLVED, as this Body hereby resolves in its meeting duly assembled on July 15, 2021, "to exclude Lumintao River from the list of rivers for the dredging activities in the Province of Occidental Mindoro to be evaluated by the IAC in view of the DPWH Dredging Clearance and approved dredging plan issued to Bluemax Tradelink, Inc. in 2018 or prior to the issuance of DENR Administrative Order No. 2020-12. Also, Bluemax Tradelink Inc. has already been undertaking desilting activities in Lumintao River, Rizal, Occidental Mindoro and has a Memorandum of Agreement with the Provincial Government of Occidental Mindoro prior to the issuance of the above Administrative Order. Therefore, Bluemax Tradelink, Inc. may commence with the implementation of a large scale dredging operation in Lumintao River, subject to the issuance of an Environmental Compliance Certificate (ECC) by the EMB Central Office."
