Sir:

Greetings in conservation!

This refers to your concern lodged to *denr8888mimaropa@yahoo.com* dated 8 February 2023 regarding the "Construction of Causeway on Calatrava Beachfront" being implemented by the Department of Public Works and Highways Romblon-District Engineering Office (DEO) funded under FY 2022 DPWH Infrastructure Program amounted to Php 91,201,467.88 that started on 25 July 2022 and to be completed on 24 June 2023.

The above-mentioned issue was referred to this Office on 8 February 2023 around 2:00 in the afternoon. Then, this Office conducted field investigation in collaboration with DENR-Environmental Management Bureau, DPWH-DEO and Municipal LGU of Calatrava, Romblon.

Based on the result of investigation, it ascertained that the said beachfront do not possess critical habitat like sea grass/mangrove ecosystem and not even declared as marine protected area. In addition, the construction of causeway serves as one of the mitigating measures against storm surges. Hence, the project will protect houses and others structures from strong waves.

Accordingly, the DENR-EMB issued Certificate of Non-Coverage (CNC) with Reference No. CNC-OL-R4B-2022-07-01162 on 01 July 2022. It has a declared project size of 0.46 Hectare situated at the shoreline beside the port, particularly at the salvage zone and intertidal zone.

Please be informed of EMB Memorandum Circular No. 2014-005 which provides that causeway projects that has a project area less than or equal to one (1) hectare (without reclamation) is only required to secure a CNC. Meanwhile, causeway projects with a project area greater than or equal to fifteen hectares (with reclamation) are required to secure an Environmental Compliance Certificate.

However, if this falls under reclamation, the Philippine Reclamation Authority (PRA) has jurisdiction over the said project and the proponent shall apply "AREA CLEARANCE" from the DENR as one of the requirements.

As per allegation of your letter citing that there was no consultations conducted, based on the documents presented by the LGU, there was consultation and dialogue with the barangay officials and fisher folks conducted by the MLGU- Calatrava held at Calatrava Municipal Fish Port on August 22, 2022 regarding the construction of causeway.

Furthermore, the Municipal LGU of Calatrava, Romblon through the Office of the Sangguniang Bayan passed a Resolution No. 67 S.2022 dated 28 November 2022 re: "A RESOLUTION APPROVING THE CONTINUATION OF THE CAUSEWAY OR RECLAMATION PROJECT IN ITS PRESENT SITE, THE EASTERN PORTION OF THE MUNICIPAL FISH PORT, AS THE DECISION IS IN CONSONANCE WITH THE WILL OF MAJORITY OF THE CALATRAVANHONS."

As a result, the DPWH-DEO issued Work Resumption Order No. 1 dated 7 December 2022 to the Sunwest Construction and Development Corp. to resume construction operations at the project site effective 9 December 2022.

At present, there is on-going operation of the causeway like sheet piling and land covering/filling works along the beach covering an area of 115 meters in length and 40 meters in width.

Again, thank you very much and we hope that we have addressed this matter accordingly.

## SB RESOLUTION NO. 67 S. 2022

A RESOLUTION APPROVING THE CONTINUATION OF THE CAUSEWAY OR RECLAMATION PROJECT IN ITS PRESENT SITE, THE EASTERN PORTION OF THE MUNICIPAL FISH PORT, AS THIS DECISION IS IN CONSONANCE WITH THE WILL OF MAJORITY OF THE CALATRAVANHONS.

WHEREAS, the Sangguniang Bayan of Calatrava, through SB Resolution No. 156 S. 2021 has requested from then DPWH Secretary Mark Villar to fund the construction of a seawall/causeway in Barangay Poblacion, this municipality;

WHEREAS, DPWH Rombion District Engineering Office, on August 2022, has informed LGU Calatrava that a fund allocation of around Ninety One Million plus Pesos (P91,000,000+) for 2022 for the seawall/causeway in Poblacion, this municipality was approved and its implementation was supposed to have started last July 2022 or a month after LGU Calatrava was informed of the fund project approval;

WHEREAS, during the August 24, 2022 consultation-dialogue conducted both by the DPWH Romblon Planning Office Staff and Sunwest Contracting Firm as the contractor of the project, Mayor Marieta Babera, the Sangguniang Bayan of Calatrava, the heads of local offices, the Poblacion Barangay Officials and the fisherfolks present requested for the transfer of the seawall/causeway project from the eastern side of the port to the western portion by arguing that there is already an existing seawall in the eastern portion, just as the project, with a total area of approximately 100 meters by 40 meters will eat up a portion of the beach fronting the

WHEREAS, the request of transfer during the consultation - dialogue was followed up by the letter of Mayor Babera and by Resolution No. 18 S. 2022 of the

Sangguniang Bayan of Calatrava, addressed to the DPWH Rombion District Office copy furnished the Honorable Congressman Eleandro Jesus Madrona, reiterating the request for transfer of the project to the western portion of the Calatrava Fish Port;

WHEREAS, in its letter addressed to the Hon. Mayor Marieta Babera dated September 15, 2022, DE Elena M. Castilan of the DPWH Rombion District Engineering Office denied the request for transfer citing the following as reasons:

- Geo-tagged photos were submitted as one among requirements prior to the release of funds. Thus, relocating the project would require approval from the department and would require technical justifications, resulting to extensive delay of project; and
- 2. Relocation of the project requires revision of approved plan which will incur more than 10% variance from original plan which may brought (sic) our designers liable to the penalties prescribed for violation of reasonable office rules and regulations.

WHEREAS, the Sangguniang Bayan of Calatrava, in its Resolution No. 37 S. 2022 has again strongly reiterated its request for transfer, copy furnished DE Elena M. Castilan of DPWH Rombion District Engineering Office, DPWH Region 4B, DPWH Central Office, the Honorable Governor Jose Riano and the Honorable Congressman Eleandro Jesus Madrona, whereas the Honorable Mayor Marieta Babera has likewise sent again her letter request for transfer;

WHEREAS, sometime this October during the distribution of medicines to the Senior Citizens of Calatrava by the Honorable Governor Jose Riano and the Honorable Congressman Eleandro Jesus Madrona, most if not all the Senior Citizens present responded positively to the continuation of the project even if this could not be transferred to the western side of the Municipal Fish Port;

WHEREAS, during the October 28, 2022 consultation meeting called by the DE Elena M. Castilan of the Romblon District Engineering Office through Municipal Mayor Marieta Babera, the structural and environmental advantages of the causeway project when located in the eastern side of the port were pitted against the possible disappearance of 100 meter beach area of Poblacion and the lack of prior consultation both with LGU Calatrava and its people which is supposedly in violation specially of Section 27 of RA 7160 on prior consultation:

WHEREAS, in the same forum, majority of the people present expressly declared their approval for the continuation of the project in its present location;

NOW THEREFORE, on motion of Hon. Elizer Fiedacan duly seconded by Hon. Ramon Reandelar, the 14th Sangguniang Bayan of Calatrava has –

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the continuation of the causeway or reclamation project in its present location, the eastern portion of the Municipal Fish Port, as this decision is in consonance with the will of majority of the Calatravanhons aired during the recent consultations facilitated by the Honorable Congressman Eleandro Jesus Madrona and by District Engineer Elena M. Castilan;

RESOLVED FURTHER, to inform DPWH Rombion, DPWH Region 4B, DPWH Central Office, the Honorable Jose Riano and Honorable Congressman Eleandro Jesus Madrona that majority of the Municipal Officials of Calatrava does not want further delays in the implementation of the project and that they believe that its advantages far outweighs the disadvantages it can give;
