Dear Engr. A. R. Collantes:

This has reference to your document, titled "Proposed Plan for the Mogpog River Dredging Operation, River Restoration and Bio-Remediation" which was submitted to this Office on January 24, 2023 for review.

In this regard, below are the comments/recommendations of this Office on the said document:

1. On sheet no. 2 of the DPWH-approved drawing plans, the targeted volume to be dredged is two million cubic meters. However, there appears to be a discrepancy in the volume stated on Sheets No. 1 and 2 of the drawing plans submitted to DENR;
2. Present a comprehensive flow sheet or process flow diagram of the entire dredging operation, especially on the dredging process at the Mogpog River delta;
3. Provide detailed explanation and comprehensive drawing plans for items A and B on Drawing Sheet No. 5 as specified in the legend. It was observed that some sections of the drawing plans lack unit of measurement. To ensure accuracy and clarity, the appropriate units of measurement on all parts of the drawing plans should be indicated;
4. Drawing plans are illegible (Drawing Sheets No. 1, 2, 3, 9, 10, 11, 12, 13, 14 & 15). Please provide legible drawing plans;
5. Provide a comprehensive site development plan for the entire dredging operation;
6. The location of the Interim Waste Stabilization Ponds (Sheet No. 26) appears to be different compared to that of the DPWH and DENR drawing plans;

7. Provide a thorough discussion, detailed drawing plans, and necessary supporting documents regarding the processes outlined in the submitted documents. This should include information on the location of the Confined Disposal Facility, Confined Aquatic Disposal, all staging areas, and procedures for handling sediment particles larger than 25 mm (pages 93 – 94);
8. Clarifications on the timeline of the dredging operation and its relation to the estimated total volume of dredged material (pages 81 – 83);
9. A comprehensive Safety and Health Program, with a corresponding planned schedule and adequate budget allocation, must be in place for the duration of the project;
10. The project must be staffed by an adequate number of safety and health practitioners; and
11. Any studies referenced in the report should be properly cited to avoid any confusion regarding the source of the study.

Please be guided accordingly. Thank you.

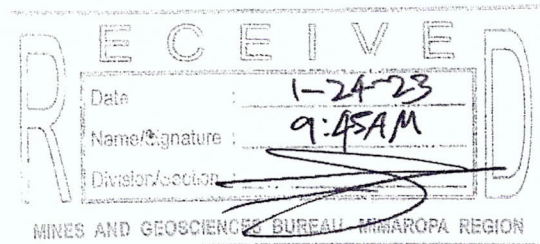

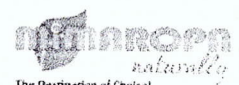
