RESOLUTION

For resolution is the *Motion for Reconsideration* dated April 7, 1982 of Dionisio Bolos Jr., herein Protestee, filed thru his counsel, Atty. Edgardo M. Siena, against the Decision dated February 2, 1982 issued by this Office in the instant case. The dispositive portion of which is hereunder quoted:

"IN VIEW OF THE FOREGOING CONSIDERATIONS, it is ordered that this case be, as hereby it is, dismissed and the case dropped from the records. The Homestead Application No. 2-2973 (E-2-2635) of Dionisio Bolos, Jr. shall be cancelled, forfeiting in favor of the government whatever amount has been paid on amount thereof. Beato Aguilar, if qualified, shall file an appropriate application for the land within sixty (60) days from the receipt of a copy of said decision, otherwise, he shall lose his rights thereto."

Records show that the final proof submitted by Beato Aguilar for his HA No. (IV-29) 00222 was approved by then Minister of Natural Resources Teodoro G. Peña on March 9, 1984.

In the case of COCOFED vs. Republic of the Philippines¹, the Supreme Court held that "the instant motion is but a mere reiteration or rehash of the arguments that have already been previously pleaded, discussed and resolved by this Court in its Decision. And considering that the motion's arguments are unsubstantial to warrant a reconsideration or at least a modification, this Court finds no reason to modify or let alone reverse the challenged Decision."

Upon careful evaluation of the instant Motion for Reconsideration, this Office finds no cogent reason to disturb or reverse the assailed Decision. The said Motion show that the issues raised therein are the very same issues, which were passed upon in the assailed Decision, and therefore, a mere rehash.

WHEREFORE, premises considered, the Motion for Reconsideration filed by Dionisio Bolos, Jr., is hereby **DENIED** for lack of merit.
