SUBJECT : RADIO PROGRAM AIRED AT 96.9 THE BAY FM SAN JOSE

In consonance with the celebration of the National Zero Waste Month with the theme, “Stepping Up Solid Waste Management through Efficient Extended Producer’s Responsibility”, and World Wetlands Day with the theme, “It’s Time for Wetlands Restoration”, this Office held a mass public airing through a radio program on February 1, 2023 which was hosted by Forest Technician II Aina Krizia S. Viray with Forest Technician I Ronnele T. Esteves and CENR Officer Efren L. delos Reyes.

In the program, the relevance of wetlands conservation and protection was highlighted with an overview of history of the celebration as well as its purpose were briefly discussed by CENRO delos Reyes. Mangrove ecosystem’s ecological and economic importance was also one of the emphasized topics during the program. CENRO delos Reyes presented the mangrove areas’ role in the protection of the coastal communities specifically during typhoons and other phenomenon as he shared the actual experiences of the residents in Sitio Wawa, Brgy. Iriron, Calintaan wherein the community acknowledged and said that during typhoon Ursula, the Mangroves protected them from waves keeping them from extreme damage.

However, it was mentioned that one of the prevailing environmental issues that wetland areas are facing is the community’s improper solid waste disposal. Most of our wetland specifically mangrove areas are being treated as dumping areas. In the continuation of the program, Forest Technician I Ronnele T. Esteves discussed the relevant provisions of the Republic Act 9003 also known as the Ecological Solid Waste Management Act of 2000. This is to remind every individual that the responsibility of managing the wastes being generated starts from the source. Every household has liability with the wastes they generate as stated at the RA 9003.
