

RE: APPREHENSION OF ABANDONED ONE (1) UNIT STIHL CHAINSAW WITHOUT SERIAL NUMBER AND WITH GUIDEBAR OREGON AT SO. KALINISAN, BRGY. BAYOTBOT, SAN JOSE, OCCIDENTAL MINDORO ON JANUARY 20, 2023 AT AROUND 11:05 IN THE MORNING.

### **RESOLUTION No. 2023-001**

This pertains to the apprehension of abandoned one (1) unit STIHL chainsaw without Serial Number and with guidebar OREGON at So. Kalinisan, Brgy. Bayotbot, San Jose, Occidental Mindoro by the Personnel of Enforcement and Monitoring Section (EMS) DENR-CENRO, San Jose, Occidental Mindoro.

### The facts of the subject case are as follows, to wit:

- 1. That, on January 20, 2023 the staff/personnel of Enforcement and Monitoring Section (EMS) of this Office conducted a monitoring and surveillance accordingly in response to a report through a cellphone call from a confidential asset that there were on-going illegal cutting activities at the vicinity of So. Kalinisan, Brgy. Bayotbot, San Jose, Occidental Mindoro.
- 2. That, indeed the report was confirmed, the team apprehended the above-subject equipment and hauled to Brgy. Hall of Brgy. Bayotbot, San Jose, Occidental Mindoro for temporary safekeeping.
- 3. That, the corresponding Apprehension Receipt with CENRO Control No.2023-F471 was issued by the apprehending officer headed by Deputy Chief, EMS, Jomar B. Serquiña
- 4. That, the Seizure Order with CENRO Control Number 2022- F471 was issued by the Seizure Officer, Land Management Officer III Rhodora A. Garcia
- 5. That, a PABATID SA PUBLIKO (Notice to the Public) was posted on January 23, January 30 and February 6, 2023 at the conspicuous places such as at Public Market of San Jose and at the Brgy. Hall of Barangay Bayotbot, San Jose, Occidental Mindoro.
- 6. That, no Administrative hearing was made because there were no claimant of the said abandoned equipment even though a Pabatid sa Publiko has been posted on three (3) separate dates and at the conspicuous places of the area of concern.

### The issues to be resolved in this case are as follow;

1. Whether or not the abandoned one (1) unit STIHL chainsaw without Serial Number and with guidebar OREGON will be confiscated in favor of the government.

For the resolution of the above stated case, the provision of the Republic Act No. 9175, Presidential Decree No. 705, as amended by the Executive No. 277, Republic Act 7161 and

the Department Administrative Order (DAO) No. 97-32, the 1997 rules for the Administrative apprehension, seizure, confiscation and disposition of illegally possessed, cut, gathered, removed, or transported forest, the machinery, equipment, tools and implements used in the connection therewith, and of the conveyances used to move or otherwise transport the same, shall be observed.

The ground for apprehension and seizure of the machinery, equipment and tools used in connection therewith is valid, as to the possession of machinery, equipment and tools during the time of apprehension is not supported with valid and/or legal documents as authorized by the law.

Republic Act No. 9175, An act regulating the ownership, possession, sale, importation and used of chainsaws, penalizing violations thereof and for other purposes, states that;

SECTION 5. **Persons Authorized to Possess and Use a Chainsaw.**- The Department is hereby authorized to issue permits to possess and/or use a chainsaw for the felling and/or cutting of trees, timber and other forest or agro-forest products to any applicant who:

- a. Has a subsisting timber license agreement, production sharing agreement, or similar agreements, or a private land timber permit;
- b. Is an orchard or root tree farmer;
- c. Is an industrial tree farmer;
- d. Is a licensed wood processor and the chainsaw shall be used for the cutting of timber that has been legally sold to said applicant; or
- e. Shall use the chainsaw for a legal purpose.

Agencies of the government that use chainsaws in some aspects of their functions must likewise secure the necessary permit from the Department before operating the same.

Presidential Decree no. 705 May 19, 1975, revising Presidential Decree no. 389, otherwise known as the Forestry Reform Code of the Philippines, as amended by Executive Order No. 277 and Republic Act 7161, states that;

SECTION 77. Cutting, Gathering and/or collecting Timber, or Other Forest Products Without License. — Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code

xxx

SECTION 77-A. Administrative Authority of the Department Head or His Duly Authorized Representative to Order Confiscation. — In all cases of violations of this Code or other forest laws, rules and regulations, the Department Head or his duly authorized representative, may order the confiscation of any forest products illegally cut, gathered, removed, or possessed or abandoned, and all conveyances used either by land, water or air in the commission of the offense and to dispose of the same in accordance with pertinent laws, regulations or policies on the matter.

xxx

Department Administrative Order No. 97-32

Sec. 2. Items subject to apprehension, seizure, confiscation and forfeiture.

a. ILLEGAL FOREST PRODUCTS - Any forest products(s) defined in Section 1(e) above that are removed, cut, collected, processed and/or transported: (a) without the requisite authorization or permit; or (b) with

incomplete required supporting documents 1; (c) with genuine authorizations or permits and/or supporting documentation that have an expired validity, have been cancelled or that contain forged entries; or (d) with spurious (fake) authorizations, permits and/or supporting documentation. In implementing these Rules, original documents shall be required at all times to actually accompany any forest products being moved or transported to any place and for any purpose. Whenever the requisite authorization and/or supporting documentation are required to but do not actually accompany the forest products, such absence constitutes a violation covered by these Rules.

- b. MACHINERY, EQUIPMENT, TOOLS AND IMPLEMENTS used in the possession, gathering, collecting, processing and/or transporting of illegal forest prducts.
- 2. The enumerated statements of facts, pieces of evidence and circumstances surrounding the above stated case, shows that the apprehended abandoned one (1) unit STIHL chainsaw without Serial Number and with guidebar OREGON shall be confiscated in favour of the government since those lumbers are product of an illegal act.

Based in the case at bar, the cutting of forest products without legal documents if proven is a violation of Section 77 of PD 705 as amended by Executive Order No. 277 and Republic Act 7161 thus subject to confiscation.

Wherefore, pursuant to Section 77 and 77-a of PD 705 as amended, section 2 and 7 of DENR Administrative Order No. 97-32, series of 1990 and based on DENR Administrative Order 2022-10 (Revised DENR Manual of Authorities for Technical Matters) the following are hereby recommended:

1. The abandoned one (1) unit STIHL chainsaw without Serial Number and with guidebar OREGON shall be confiscated in favour of the government since those lumber are products of an illegal act.
