This has reference to your memorandum anent above-subject received by this Office on February 1, 2023 relative to the 8888 Citizen's Complaint Hotline Ticket Reference Number 620221211-771-10.

In which the complaint Mr. Unisan Soriano Madayag has alleged the undersigned in demanding Php100,000.00 pesos in exchange for the issuance of Tree Cutting Permit that he requested for the past two (2) directed the undersigned outrightly denied the said allegation considering that the undersigned immediately directed the concerned technical staff and acted his request with due diligence and strict observance of the due process in consideration of the complexity of circumstances that had arised during the conduct of field timber inventory survey and investigation that eventually caused the un-intended delay for the issuance of the cutting permit. Moreso, that Mr. Madayag has been well informed on the series of actions taken by this Office.

It could be gleaned that Mr. Madayag requested a tree cutting permit of the planted trees within his titled property on February 14, 2021, in which technical staff from this Office conducted tree inventory. However, it was found out that the subject titled property and trees planted therein is in dispute/conflict with the Valiente Family claiming that said parcel of land is covered by a Certificate of Stewardship Contract (CSC) issued by the DENR and that the subject trees are also planted by them and not Mr. Madayag. Records of investigation showed that the titled property of Mr. Madayag containing an area of 10.1681 hectares is almost identical to the area of CSCs awarded to Mr. Savellano Valiente, Sr. and Mrs. Lydia Valienta having an individual area of 5.0 heactres and the Gmelina trees are planted by the named CSC holders funded by the DENR under the Upland Development Program (UDP). As a result, Mr. Madayag were immediately informed on April 14, 2021 that his request for cutting permit is pending in abeyance the conduct by further investigation.

Records also showed the series of investigation/meetings that were conducted by this Office with the objective for amicable settlement to facilitate the issuance of the requested tree cutting permit, however, both parties despite much effort failed to come into an amicable settlement. As a result, the investigation with categorical recommendations were forwarded to the PENRO/Regional Office requesting guidance of further action.

That on January 17, 2023 this Office received the advanced copy of the Memorandum from the Regional Executive Director-MIMAROPA Region with specific instructions for compliance of the PENRO and CENRO, particularly for the CENRO to compute the 25% government share from the proceeds of the planted trees considering that the plantation was funded under the government/DENR Upland Development Project and to process the application for cutting permit in favor of Mr. Madayag.

As a result, this Office already informed Mr. Madayag of said instruction but refused to pay the 25% government share with his argument that said trees are planted on his private property.

Foregoing considered, it is clear that the undersigned has just observed due diligence and due process in acting such request and never demanded any amount in exchange for such request, and that the allegations is just meant to put pressure to the undersigned to give way on his request without observing the standard operating procedure and existing laws, rules and regulations on the matter.

#### I. REFERENCE

This is in connection to the email sent from the Office of the President: 8888 Citizen's Complaint Hotline with the ticket reference number G20221211-771-10. The complaint concerned alleged irregularities in the issuance of Tree Cutting Permits in the Community Environment and Natural Resources (CENRO) San Jose, Occidental Mindoro.

#### II. BACKGROUND

On February 15, 2021, Mr. Servillano Valiente, Jr. sent a letter to the OIC PENR Office Mamburao Occidental Mindoro and subsequently referred to this Office for proper action concerning the land located at Sitio Cambiswer, Poblacion, Calintaan, Occidental Mindoro that according to Mr. Valiente the Bureau of Forest Development had issued a Certificate of Stewardship Contract to Mrs. Lydia and Mr. Servillano Valiente, Sr (the parent of the letter sender) on the said land. Further, that on May 2017, Mr. Unisan Madayag bought the same land from Teodora Motella, the said land has a monument with caption BFFR however the monument of Public Land Survey (PLS) is also present in the same area which was allegedly placed there by Mr. Unisan Madayag. Mr Valiente prayed that this office may provide assistance because Mr. Unisan Madayag is claiming the land which they have invested considerable improvements. (See Annex-A for more details)

On February 14, 2021, Mr Unisan Madayag, requested to this Office to apply for Certificate of Tree Cutting Ownership (Gmelina and Mahogany Trees in which he allegedly claimed that he planted those trees) on his titled land with TCT No. 063-2009000317 located at Sitio Cambiswer Brgy Poblacion Calintaan, Occidental Mindoro. (See Annex-B for more details)

On April 14, 2021, this Office sent a letter to Mr. Unisan Madayag as follows:

"Please be informed that this Office has already conducted an inventory of the said trees on March 3-4, 2021 covering Seven Hundred Thirty Two (732) Gmelina trees with total gross volume of 244.97 cubic meters.

On April 22, 2021, this office conducted an investigation and prepared a Completed Staff Work (CSW) regarding the letter of Mr. Valiente. The following are the recommendations:

 Inform Mr. Unisan Madayag that the trees planted in his property is a biological asset of the Government and therefore, subject to recovery of all the cost incurred in the establishment of the said UDP project,

2. To inform Mr Valiente that the Certificate of Stewardship Contract (CSC) could no longer ne renewed being expired in Calendar Year 2012 as it is issued with the title in

1981 prior to the issuance of Certificate of Stewardship Contract (CSC),

 The CENRO San Jose shall facilitate the process under existing laws, rules and regulations to formally cancel and or terminate the Certificate of Stewardship Contract (CSC);

4. To issue a cutting permit giving due consideration to recover the amount spent by the

Government in planting the Gmelina tress under UDP, and;

Also the holder of Certificate of Stewardship Contract (CSC) to be duly compensated
of their labor pursuant to Article 448 of the Civil Code of the Philippines. (see AnnexD for more details)

On the same date, this office has submitted to the Provincial Environment and Natural Resources Office PENRO Mamburao Occidental Mindoro the Completed Staff Work (CSW) for transmittal to the Regional Office for proper decision of the case. (See Amex-E for more details)

The OIC-Provincial Environment and Natural Resources Office Mamburao Occidental Mindoro issued a memorandum to the Regional Executive Director DENR-MIMAROPA thru the ARD for Technical Services regarding the LETTER DATED FEBRUARY 15, 2021 OF MR. SERVILLANO A. VALIENTE JR. REGARDING A PARCEL OF LAND LOCATED AT SITIO CAMBISWER BARANGAY POBLACION CALINTAAN, OCCIDENTAL MINDORO whereas it was instructed that our Office has recommendation of CENRO San Jose Occidental Mindoro for the Issuance of Clearance to cut for the Gmelina trees inside the private properties of Mr. Unisan Madayag but in accordance with existing laws, since the area was part of the UDP Reforestation Project in 2009. VALIENTE REGARDING CERTIFICATE OF STEWARDSHIP CONTRACT ISSUED WITHIN THE MUNICIPALITY OF CALINTAAN, OCCIDENTAL MINDORO whereas it was instructed to submit report in CSW format to include the Performance Evaluation Sheet, Land Classification status, GIS generated map, geo tagged photos and shapefile which shall serve as Means of Verification (MOV) together with your comment and recommendation. On November 08, 2021, this Office has submitted a memorandum thru the PENR Officer reiterating the Completed Staff Work (CSW) Submitted on April 22, 2021 with subject SUBMISSION OF ACCOMPLISHMENT REPORT ON THE ASSESSMENT OF CERTIFICATE OF STEWARDSHIP CONTRACTS (CSC's) WITHIN THE ADMINISTRATIVE JURISDICTION OF CENRO SAN JOSE, OCCIDENTAL MINDORO to the Regional Executive Director DENR –MIMAROPA. This Office recommended for the cancellation for the reason that their stewardship areas are within titled Alienable and Disposable Lands, in this regards the investigation report dated April 22, 2021 in Completed Staff work Format (CSW) together with pertinent documents are submitted.(See Annex-I for more details)

On December 17, 2021, The Regional Executive Director Issued a memorandum dated November 24, 2021 to the OIC PENR Officer Occidental Mindoro with attention to the CENR Officer San Jose Occidental Mindoro relative to the submitted CSW report on the conducted evaluation / assessment of Certificate of Stewardship Contracts (CSC) issued to Mr. Servillano Valiente, Sr. and Lydia Valiente, both covering an area of five (5) hectares issued on March 28, 1995 and had expired on March 28, 2020. Upon verification, the subject CSC were identified to be located within the titled Alienable and Disposable land. Further, the DENR-Regional Office concurr the recommendation of the CENR Officer Efren L. Delos Reyes stipulated in the Memorandum for the PENRO dated April 22, 2021. The DENR- Regional Office reminded to conduct verification on the legal status of all open areas subject of tenure application to prevent such incident from happening in the future. (See Annex-J for more details)

On January 4, 2022, the OIC, PENR Office Mamburao Occidental Mindoro referred the memorandum dated December 17, 2021 of the Regional Executive Director to this Office relative to the SUBMISSION OF ACCOMPLISHMENT REPORT ON THE ASSESSMENT OF CERTIFICATE OF STEWARDSHIP CONTRACTS (CSC's) WITHIN THE ADMINISTRATIVE JURISDICTION OF CENRO SAN JOSE, OCCIDENTAL MINDORO to the Regional Executive Director DENR –MIMAROPA. Relative thereto, be reminded to conduct verification of the legal status of all open areas subject of tenure to prevent such incident from happening in the future. (See Annex-K for more details)

On January 28, 2022, the Regional Executive Director issued a memorandum to the OIC, PENR Officer Mamburao Occidental Mindoro regarding the ACCOMPLISHMENT REPORT ON THE ASSESSMENT OF CERTIFICATE OF STEWARDSHIP CONTRACTS (CSC's) WITHIN THE ADMINISTRATIVE JURISDICTION OF CENRO SAN JOSE, OCCIDENTAL MINDORO to the Regional Executive Director DENR—MIMAROPA that per review of the submitted reports of various dates, it was noted that a total of eight hundred fifty eight (858) CSCs has been evaluated as of this date in which the Stewardship Contract of Mr Servillano and Lydia Valiente, Sr are included. For the CSCs that are recommended

for cancellation, it was also noted that the submitted MOVs including the photocopy of CSCs were already stamped with "cancelled". Relative to this, that Office would like to reiterate that unless all the necessary procedures in cancellation stipulated under Section of DMC 21-1993 and the recommended actions have been reviewed and affirmed by this Office, stamping of the original copy of CSC should not be done. (See Annex-L for more details)

Note: According to the personnel of this office who personally delivered the letter, Mr Madayag Refused to receive the letter of invitation because according to him nothing will happen on that settlement. (See Annex-O for more details)

On April 18, 2022, The Senior Ecosystem Management Specialist Mr Orlino B. Gacuan, Legal Officer Sancho C. Niedo, and Forester Augreth S Saligumba conducted an evaluation / assessment of Certificate of Stewardship Contracts (CSC's) issued to Mr. Servillano Valiente, Sr. and Lydia Valiente, both coering an area of five (5) hectares located at So. Cambiswer Brgy. Poblacion, Calintaan, Occidental Mindoro. They recommend the following to wit:

1. As to 1st recommendation concurred by the Regional Office, "To Inform Mr. Valiente that the Certificate of Stewardship Contract (CSC) could no longer be renewed being expired on Calendar year 2012as it is issued with title on 1981 prior to the issuance of Certificate of Stewardship Contract". Letters dated June 3, was delivered to the Valientes thru the postal Office however, there were no responses rom the Valientes regarding the letters of cancellation and they had contested during the Two (2) meeetings that were conducted las Friday February 24, 2022 and March 10, 2022. Considering that the land involved is within a Alienable and Disposable Land and it is covered by OCT No. P-637. As of to date this office is still waiting for the Notice of Cancellation to be issued by the Provincial Office;

2. The office had already conducted CSC evaluation / assessment and was recommended for cancellation considering that said areas falls within the Alienable and Disposable Lands as per LC map 678 July 29, 1927 and covered by Original Certificate of Title (OCT) P-637 issued to Mrs. Teodora Ausan VDA De Motilla on May 25, 1981 prior to the issuance of Certificate of Stewardship Contracts (CSC's) on May 15 and October 12, 1987;

3. This office ould not facilitate nthe issuance of Tree Cutting Permit, considering that the harvesting of said planted trees is not covered by DAO 2020-18 and only the Regional Office could only facilitate the issuance of the said Tree Cutting Permits

4. The parties did no agreed / settle on the amicable settlement which is to settle under Article 448 of the Civil Code. Further, the demand of Mr. Valiente of One (1) Million compensation is unreasonable which makes Mr Madayag to disagree on the said settlement, and that's the reason why the settlement was not reach into agreement. The fourth order was not resolved thru an administrative procedure therefore it is respectfully recommended that the matter be brought up to higher authorities for their comment, suggestion and recommendation before going to judicial proceedings. (See Annex-O for more details)

On April 19, 2022, this office has submitted a report in connection to the memorandum of the Regional Executive Director dated December 17, 2021 regarding the accomplishment report of the assessment of Certificate of Stewardship Contract within the Administrative Jurisdiction of CENRO San Jose Occidental Mindoro whereas this office has reiterated the recommendation for the cancellation of said CSC and likewise seeking assistance / advice to settle the issue between both parties as planters in good faith ( Heirs of Valiente's) against the legal owner ( Mr. Madayag) of the titled land in consideration to Article 448 of the Civil Code of the Philippines to facilitate the eventual issuance of cutting permit under the existing laws, rules and regulations. (See Annex-Q for more details)

On April 21, 2022, this Office has sent a letter to Mr. Servillano Valiente Jr. in response to his complaint to the Presidential Complaint Center with reference Code No. PM-GDP-03-07-2022-017 (DENRCO-AS RMD-2022-007318) in which he pointed out the cancellation of the said stewardship contracts and allegedly the whole area of 10 hectares was offered by this office to Mr. Madayag for sale. Based on record, the said lot was sold by Mrs. Teodora Vda. De Motilla to Mr. Unisan Madayag dated July 13, 2017 and the letter sender was informed that the basis of cancellation of the Stewardship Contract is the DENR Memorandum Circular No 21 Series of 1993. (See Annex-R for more details)

On April 27, 2022 This Office sent a memorandum to the Head, DENR Action Center / Hotline Merlinda R. Manila thru the OIC, PENR Officer Mamburao Occidental Mindoro regarding the reference code no. PM-GDP-03-07-2022-017 DENRCO-AS RMD 2-22-(007318) RE letter from Mr. Servillano Valiente, Jr. requesting assistance on his land problem involving land problem of 10 hectares parcel of land in Sitio Poblacion, Calintaan, Occidental Mindoro. This is in compliance by this office on April 19, 2022 respectfully furnished the copy of our letter to Servillano Valiente, Jr. sent thru Philippine Postal Corporation as proof of previous action / resolution conducted by this office related to his complaint. (See Annex-S for more details)

On May 02, 2022, this Office prepared and submitted a Completed staff work in response to the Complaint of Mr. Valiente dated April 26, 2022 as a result, this office arranged a meeting on February 24, 2022 to settle the dispute between the heirs of Valiente and Mr. Unisan Madayag regarding the harvesting / cutiing of the planted trees (Gmelina) in compliance to the Memorandum instruction dated December 17, 2021 from the Regional Office. However, even in the succeeding meetings they were not able to come up with an agreement in order to facilitate the issuance of cutting permit. Mr Madayag is willing to reimburse the 25 % government share from the proceeds / sale of the planted trees (Gmelina), considering that the said plantation was funded under the Upland Development Project in 2009. But he is not willing to pay the amount of one Million (1,000,000.00) pesos being demanded by the Valiente as payment of their labor in developing the area and protecting the palnted trees as a result, this office sent a letter to Mr. Servilliano Valiente, Jr. thru the Philippine Postal Corporation (PPC) this is in response to his letter dated February 18, 2022 addressed to the Presidential Complaint Center (PCC) transmitted to the OIC, DENR Sectretary Jim O. Sampulna thru the Head Executive Assistant and conveyed to the DENR Action Center / Hotline. (See Annex-T for more details)

On December 19, 2022, the Regional Executive Director issued a memorandum to the OIC PENR Officer Mamburao Occidental Mindoro regarding the issue between Mr. Servillano Valinete and Lydia Valiente, CSC Holders, and Mr. Unisan Madayag, title holder under Transfer of Certificate of Title No. 063-2019-000317. The Following directives in the memorandum dated December 17, 2021 issued by the Regional Executive Director Maria Lourdes G. Ferrer are hereby amended and clarified as follows;

#### 1. The PENR Officer, Occidental Mindoro

a. To avoid Mr. Servillano Valiente and Ms. Lydia Valiente, as builders in good faith, to file the appropriate case before the court to compel Mr. Un isan Madayag, landowner, to choose between two (2) options; (1) to appropriate the planted trees by paying the indemnity required by law; or (2) to sell the land to the builder. The issue or their settlement is beyond our office's jurisdiction, thus resort to the courts is needed.

#### 2. The CENR Officer, San Jose Occidental Mndoro

a. There is no need to renew the said CSC because it already expired in 2012.
 Considering that the areas formerly covered by the CSC were found to be within agricultural (alienable and Disposable) Land, issuance of CSC is no longer feasible;

b. To compute the Government share spent in expired CSC which were part of the UDP in 2009. Per report, Mr. Madayag is willing to reimburse the 25% government share from the proceeds of the planted trees, considering that the plantation was funded under the Upland Development Project 2009; and c. To process the application for cutting permit in favor of Mr. Madayag, as title holder, in accordance with applicable rules and regulations, and subject to the provisions of Article 448 of the Civil Code and/or the pronouncement of the court, as the case may be. (See Annex-U for more details)

On January 17, 2023, this Office received the advance copy of the memorandum dated December 19, 2022 issued by Regional Executive Director Lormelyn E. Claudio, CESO IV. CENR Officer Efren L. Delos Reyes held a meeting with section chiefs to discuss the instructions and the steps that shall be made in processing the said Tree Cutting Permit. It was agreed that Mr. Unisan S. Madayag should pay the 25% government share prior to the release of the permit and computed as follows;

(Net Volume x Prevailing Stumpage Value (\$16.00 bd.ft.)) x 25% Government Share

The net harvestable from the planted Gmelina and Mahogany trees based on the conducted 100% tree inventory is 171.479 cubic meters or 72,707.096.

On January 25, 2023, this Office drafted a letter addressed to Mr. Unisan S. Madayag informing him the decision of the Regional Office in regard to the on-going dispute. Likewise, the release of the requested Tree Cutting Permit is subject to the payment of 25% government share amounting to Php 290,828.38 as per memorandum dated December 19, 2022 from the Regional Executive Director Lormelyn E. Claudio, CESO IV. Such as follows: (See Annex-V for more details)

On January 27, 2023, the Office of the President 8888 Citizen's Complaint Hotline sent this Office a complaint coming from Mr. Unisan Madayag thru Email dated December 11, 2022 with subject: Complaint regarding alleged Irregularities relative to issuance of Tree Cutting Permits in Community Environment and Natural Resources Office (CENRO) San Jose Occidental Mindoro. Mr Madayag Emailed the Presidential Complaint Hot line stating "Inirereklamo ko ang Community Environment and Natural Resources Office (CENRO) Head na si Efren L. Delos Reyes ng Department of Environment and Natural Resources (DENR) Occcidental Mindoro dahil ito sa paghold ng aking cutting permit sa loob ng dalawang (2) taon. Nakapag-submit na ako ng lahat ng requirements pero hindi ako ma-approve dahil humihingi siya ng lagay na One Hundred Thousand Pesos (Php 100,000.00) para sa mga puno kong mapuputol. Ang nais ko sana ay maibigay na ang aking cutting permit na napakatagal nang binibinbin sa kanyang opisina. (See Annex-X for more details)

Mr. Unisan S. Madayag went to CENRO San Jose on January 26, 2023, to receive the letter informing him of the conditions in the approval of his Private Land Timber Permit (PLTP). He argued, however, that he should only pay the 25% government share after disposing of the cut trees.

On January 30, 2023, CENR Officer Efren L. Delos Reyes and the section chiefs met with Mr. Unisan S. Madayag to further discuss the conditions for PLTP approval. The most recent memorandum was dissected and thoroughly explained in order to comprehend the actions taken by this Office. Mr. Unisan S. Madayag contended that not all of the trees planted on his property are merchantable and that paying the Php 290,828.38 would be unfair to him. At the end of the meeting, he was advised to request that only merchantable trees be inventoried, and that only reinvented trees be granted a PLTP.

#### III. FINDINGS

All reasonable efforts were made to resolve all disputes, and this Office followed all applicable procedures. Likewise, CENRO San Jose's actions were all documented and supported. The cutting permit covering the planted Gmelina and Mahogany trees with a net harvestable

volume of 171.479 cubic meters or 72,707.096 board in Mr. Unisan S. Madayag's property shall be approve subject to the payment of 25% government share amounting to memorandum dated December 19, 2022 from the Regional Executive Director Lormelyn E. Claudio, CESO IV.

#### IV. RECOMMENDATION





- 2. Issues that will arise from the cutting should be addressed directly by the permittee;
- The trees requested to be cut and parts thereof belong to the applicant. In case of the need to transport timber and/or lumber to be derived therefrom outside the plantation area, necessary transport documents shall be secured from this Office;
- 4. Prior to the cutting operations, the permittee is advised to install a placard or signboard measuring 4x8 within the cutting area informing the public that the tree cutting operation is authorized by the DENR and indicating the name of the permittee, the purpose of tree cutting and the number of trees to be cut and to use chainsaw that is duly registered with the DENR;
- 5. The permittee shall be required to reimburse the 25% government share amounting to Php 290,828.38 in accordance to the memorandum dated December 19, 2022 from the Regional Executive Director Lormelyn E. Claudio, CESO IV in reference to DAO No. 98-42 prior to the tree cutting operation as computed below: (Net Volume x Prevailing Stumpage Value (\$\interprecep16.00/bd.fl.)) x 25% Government Share
- The tree cutting operations shall, at all times, be under direct supervision of the CENRO San Jose, Occidental Mindoro, or our duly authorized representatives, hence the permittee shall inform this Office on the dates of actual cutting/harvesting operations;

Violation of any of the terms and conditions of the permit to be issued shall be sufficient ground for the termination/cancellation of this permit, subject to due process without prejudice to the imposition of appropriate penalties pursuant to existing regulations, and one strike policy to concerned DENR official(s) and/or personnel(s).

This refers to your Memorandum regarding the issue between Mr. Servillano Valiente and Lydia Valiente, CSC holders, and Mr. Unisan Madayag, title holder under Transfer Certificate of Title

Records show that on May 25, 1981, Original Certificate of Title No. P-637, with a total land area of 10.1681 hectares, was issued to Mrs. Teodora Asan vda. de Motilla. This is almost identical to the subject CSCs issued to the Valientes in 1987. Moreover, based on actual field survey, an approximate 8.21 hectares out of the 10 hectares covered by the CSCs falls within agricultural (alienable and disposable) lands.

Article 448 of the Civil Code provides that:

The owner of the land on which anything has been built, sown or planted in good faith. shall have the right to appropriate as his own the works, sowing or planting, after payment of the indemnity provided for in Articles 5461 and 5482 or to oblige the one who built or planted to pay the price of the land, and the one who sowed, the proper rent. However, the builder or planter cannot be obliged to buy the land if its value is considerably more than that of the building or trees. In such case, he shall pay reasonable rent, if the owner of the land does not choose to appropriate the building or trees after proper indemnity. The parties shall agree upon the terms of the lease and in case of disagreement, the court shall fix the terms thereof.

In Pablo M. Padilla, Jr. and Maria Luisa P. Padilla, v. Leopoldo Malicsi, et al<sup>3</sup>., viz. Article 448 of the Civil Code gives a builder in good faith the right to compet the landowner to choose between two (2) options: (1) to appropriate the building by paying the indemnity required

Art 546 Necessary expenses shall be refunded to every possessor, but only the possessor in good faith may retain the thing until he has

Useful expenses shall be refunded only to the possessor in good faith with the same right of retention, the person who has defeated him in the possession having the option of refunding the amount of the expenses or of paying the increase in value which the firing may have

Expenses for pure luxury or recre pleasure shall not be refunded to the possessor in good faith; but he may remove the ornaments with which be has embelished the principal thing if it suffers no injury thereby, and it his successor in the possession does not prefer to refund the amount expended.

The owner of the building erected in good faith on a land owned by another, is entitled to retain the possession of the land until he is paid the value of his building, under article [546]. The owner of the land, upon the other hand, has the option, under article [448]. either to pay for the building or to sell his land to the owner of the building. But he cannot, as respondents here did, refuse both to pay for the building and to sell the land and compel the owner of the building to remove it from the land where it is erected. He is entitled to such remotion only when, after having chosen to sell his land, the other party fails to pay for the same.

Rosales v Castellfort<sup>5</sup> has emphasized that the choice belongs to the landowner, but the must choose from the two (2) available The choice belongs to the owner of the land, a rule that accords with the principle of accession, i.e., that the accessory follows the principal and not the other way around. Even as the option lies with the landowner, the grant to him, nevertheless, is preclusive. The landowner cannot refuse to exercise either option and compel instead the owner of the building to remove it from the land.

In view of the foregoing, the directives in the Memorandum dated December 17, 2021 issued by then Regional Executive Director Maria Lourdes G. Ferrer are hereby amended and clarified. The following are directed:

#### 1. The PENR Officer, Occidental Mindoro

a. To advise Mr. Servillano Valiente and Ms. Lydia Valiente, as builders in good faith, to file the appropriate case before the court to compel Mr. Unisan Madayag, landowner, to choose between two (2) options: (1) to appropriate the planted trees by paying the indemnity required by law; or (2) to sell the land to the builder. The issue of their settlement is beyond our office's jurisdiction, thus, resort to the courts is needed.

#### 2. The CENR Officer, San Jose, Occidental Mindoro
