

This has reference to the submitted Memoranda of Agreement (MOA) which emphasize the roles and responsibilities of the LGUs and the DENR, including joint partnership and resources sharing and complementation for FLUP implementation.

It has been observed by the undersigned that the FLUPs and the MOA do not include specific areas identified for production and protection forests. During the Management Conference held last November 2022, you may recall that the undersigned has directed you to assist the LGUs in identifying such areas to help prevent or abate the cutting of trees in the protected forests/areas. Further, you may recall that the matter should be in line with Section 8 of Republic Act No. 10176. otherwise known as the "Arbor Day Act of 2012" stating that "all able-bodied citizens of the Philippines, shall be required to plant one (1) tree every year". Hence, the proposed system or mechanism to mobilize citizens and monitor such program should be in place and included in the FLUPs. During our meeting in Palawan, the LGUs in the provincial and municipal levels indeed welcome the said endeavor. As discussed, the production forest may also employ agroforestry, which could prevent illegal logging for the production of charcoal and other household and domestic requirements.

Therefore, you are directed to coordinate with your respective MENROs and amend the FLUPs and even the signed MOAs, if there are already have been signed to ensure the implementation of this. Submit your Action Plan on or before the end of January 2023.
