In connection with the flood control program of the government pursuant to the JMC No. 2019-01 among the department of Environment and Natural Resources ("DENR"), Department of Public Works and Highways ("DPWH"), Department of Interior and Local Government ("DILG"), and Department of Transportation ("DOT").

We, Triton Construction and Development Corporation (TCDC) with a primary engagement in the business of infrastructure and development, with a classification as triple A or AAA by the Philippine Contractors Accreditation Board (PCAB), a sister company of Bird's Nest Resources Corporation under the Wellex Group of Company (see attached company profile), hereby express with formal intent to assist in technical study and dredging the heavily-silted Amnay River and Patrick River at no cause to the provincial government of Occidental Mindoro.
