



Further, in preparation for the re-opening of tourism activities in the Municipality of Taytay, a joint clearing/clean up drive was conducted at Kuyawyaw Falls in Barangay Cataban by the PAMO MSPLS together with the Municipal Tourism Office, fraternity/sorority of Taytay, tour guides of Kuyawyaw Falls, Barangay Officials of Cataban and various concerned local sectors.

The collection center in Kuyawyaw Falls is scheduled for rehabilitation once the materials needed are available. As mentioned in our previous reports, the collection center was damaged by typhoon Odette in December 2021.

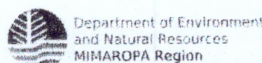
Please be informed that on September 6, 2022, the Intel Operatives of Naujan Municipal Police Station (MPS) conducted Intel monitoring which resulted to the apprehension of one (1) bird cage containing nineteen (19) heads of Eastern Spotted Dove (Bato-Bato birds) under the possession of Mr. Teotimo M. Magnaye in Brgy. Del Pilar, Naujan, Oriental Mindoro. Accordingly, Mr. Magnaye failed to present any permit issued by the DENR for the possession of said wildlife. Criminal case was filed by the Naujan MPS against Mr. Magnaye for violation of RA 9147 under NPS docket no. INQ-225-00156 before the Office of Provincial Prosecutor. On September 08, 2022, the accused was temporarily released through a court order upon posting of required cash bail.

On September 07, 2022, the apprehended wildlife was turned-over to CENRO Socorro personnel for custody. Further, said wildlife species was released back to the wild within the forested area in Brgy. Pasi 2, Socorro, Oriental Mindoro upon assessment and determined that these were in good condition.

This refers to the attached Memorandum dated December 05, 2022 from the PENR Officer, Palawan with the memorandum submitted by Atty. Jazmin D. Altea, regarding the above-cited subject.

Please be informed that the following cases were filed due to illegal structures in Snake Island: Criminal Case No. 24180 entitled "*People of the Philippines v. Felix Beltran and Jenelyn Beltran*"<sup>1</sup> and Criminal Case No. 24254 entitled "*People of the Philippines v. Rodolfo Bernardo*"<sup>2</sup>, both for Violation of Section 78, PD 705.

Please be informed further that the counsel of Mr. Beltran questioned the enforceability of DENR Administrative Order (DAO) No. 2011-12 establishing Snake Island as the DENR National Coastal and Marine Center Research, alleging lack of publication in the newspaper of general circulation or Official Gazette.

Atty. Altea manifested that the said DAO is not required to be published in a newspaper of general circulation or Official Gazette as the agency's administrative rules and regulations are only required to be submitted to the Office of the National Administrative Register (ONAR), the central repository of all administrative rules and regulations in the UP Law Center. We concur with Atty. Altea's manifestation that all DAOs must be submitted to the ONAR of the UP Law Center.

We are attaching a copy of DAO No. 2011-12 downloaded from the DENR Databank<sup>3</sup>. It is respectfully recommended that there is a need to check and verify whether DAO No. 2011-12 was submitted to the ONAR to avoid any further problem that we may
