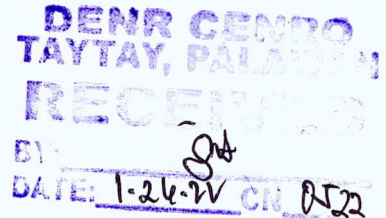

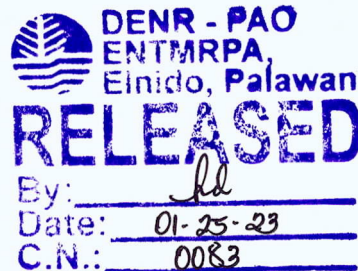

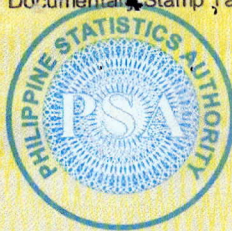
In view hereof, it is respectfully requested that the records as to civil status since the marriage be updated and her full name be registered as LANIE JANE R. CACACHA thenceforth.
