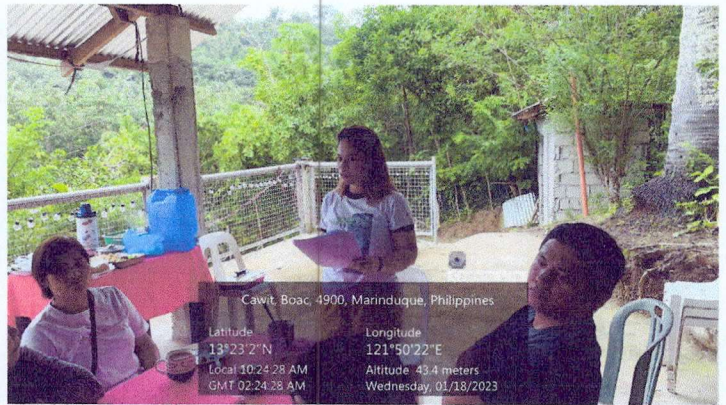

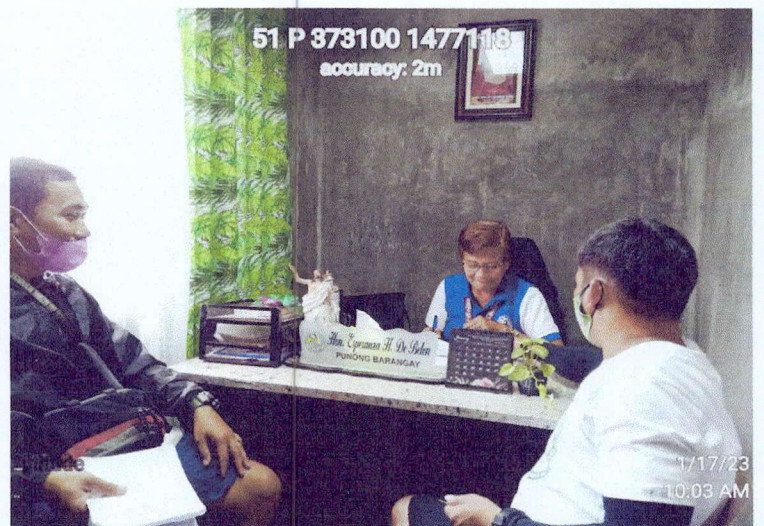


SUBJECT : REPORT ON THE MONITORING ACTIVITIES OF WILDLIFE ENFORCEMENT OFFICER OF MONITORING AND ENFORCEMENT SECTION FOR THE MONTH OF JANUARY CY 2023

In accordance with the target of this Office under Operation Against Illegal Environment and Natural Resources Mobilization of Wildlife Enforcement Officers (WEO), please be informed that the undersigned personnel of Monitoring and Enforcement Section conducted the following activities in relation with the afore-mentioned subject target, to wit;

- On January 17, 2023, conducted coordination with Barangay Local Government Units (BLGUs) within Brgys. Cawit, Boac; Brgy. Dos and Masiga, Gasan, Marinduque. Likewise, also coordinated with Philippine National Police-Maritime Group, Coast Guard, Civil Aviation Authority of the Philippines (CAAP) and Philippine Ports Authority within the municipality of Gasan, Marinduque. In order to established good communication and to have smooth implementation of programs against illegal wildlife trade activity.
- On January 18, 2023, the undersigned together with For. I Jelomy H. Mahayag and Forest Ranger Menchie Radovan conducted first meeting for CY 2023 with Butterfly permittee/holders within Boac, Marinduque. During the meeting, we discussed the flow or process of the application of permits and requirements to be submitted based on the existing guidelines. Likewise, permittee raised some questions if they can apply Wildlife Farm Permit (WFP) regarding the propagation of beetles in their area.
- Discussed conservation and protection of wildlife resources and their habitats pursuant to Republic Act No. 9147 "Wildlife Conservation and Protection Act" and other DENR forestry laws, rules and regulations.
