

ANTECEDENT FACTS

AAP No.: 2022-

In compliance with the provisions of DENR Administrative Order No. 97-32 (DAO 97-32), an **Administrative Adjudication Proceeding** has been commenced relative to the abovecited subject. The corresponding **Summary Confiscation Hearing** was scheduled by the undersigned hearing officer on **09 November 2022** at DENR-CENRO Socorro, Barangay Pasi II, Socorro, Oriental Mindoro.¹

The apprehending officers in this proceeding are **PSSg Miko G. Lopez** and **PCpl Marco A. Hicban** of the Naujan Municipal Police Station (Naujan MPS) while the respondent involved is **Janly R. Aceveda**, resident of Barangay Mahabang Parang, Naujan, Oriental Mindoro. The narration below and recommendation of the hearing officer are based on material and relevant pieces of evidence gathered from them.

Version of the Apprehending Officers

At around 1:45 in the afternoon of 18 October 2022, apprehending officers chanced upon respondent Aceveda walking and carrying a chainsaw. The former introduced themselves and asked for the necessary permit relative to its possession and/or transportation which the latter failed to provide. Hence, respondent Aceveda was arrested and the apprehended chainsaw was marked as "MAH-1". ²

On 19 October 2022, apprehending officers coordinated with DENR – CENRO Socorro for the turn-over of chainsaw and for issuance of Certification of its non-registration. ³ An **Apprehension Receipt** was issued on the same date.⁴

The corresponding **Seizure Order** and **Seizure Receipt** were then issued by the undersigned to take official custody of the apprehended chainsaw, with details to wit:⁵

Per Certification issued by Marjorie Joyce S. Acuzar, Administrative Officer I (Records Officer) of DENR-CENRO Socorro, there is no registered chainsaw under the name of respondent.⁶

Further, there is a *pending* criminal case against respondent Aceveda for violation of Section 7(a) of Republic Act No. 9175 or "Chain Saw Act of 2002" docketed as Criminal Case No. 6710.⁷

Version of the Respondent

Respondent admitted that the chainsaw is unregistered but interposed the defense that he does not own it instead such belongs to a certain "Robin Aguila", resident of Cavite who has a parcel of land in Barangay Mahabang Parang.⁸

He was allegedly arrested in the following manner:



RECOMMENDATION

WHEREFORE, undersigned hearing officer, respectfully recommends the following:

The unregistered chainsaw with crankcase number 04201509280427 shall be confiscated in favour of the government and be disposed of in accordance with existing laws and procedures.

Section 7, Paragraph (a) of RA 9175 provides:

Selling, Purchasing, Re-selling, Transferring, Distributing or Possessing a Chain Saw Without a Proper Permit. - Any person who sells, purchases, transfer the ownership, distributes or otherwise disposes or possesses a chain saw without first securing the necessary permit from the Department shall be punished with imprisonment of four (4) years, two (2) months and one (1) day to six (6) years or a fine of not less than Fifteen thousand pesos (P15,000.00) but not more Thirty thousand pesos (30,000.00) or both at the discretion of the court, and the chain saw/s confiscated in favor of the government.

Per record of DENR-CENRO Socorro, no Certificate of Registration was issued to respondent Aceveda and even to its alleged owner, "Robin Aguila". Hence, it is clear that possession, transport, and/or use thereof is illegal subject to administrative confiscation.
