



Gentlemen:

We would like to follow-up the PAMB endorsement/resolution on the Agro-Forestry Coffee Plantation Project of CAMPAL and SOCResources, Inc. (SOC) in the CAMPAL Ancestral Domain.

In August 24, 2021, the great majority of the PAMB En Banc approved the project and its endorsement/resolution. The documentation is needed to obtain an ECC. In a letter dated January 11, 2022 SOC sent a follow-up letter on the endorsement to the PAMB to which the PAMB replied that the project had yet to be ratified. On April 7, 2022 the PAMB En Banc again voted on and ratified the project for the issuance of the PAMB Endorsement/Resolution.

Representatives of CAMPAL and SOC followed-up in June and July and were told that the document has been sent through channel for approval and signature. It is more than a year since project approval and more than six (6) months since the ratification, and we have yet to receive a copy of the endorsement.

We therefore request for a copy of the endorsement.

We pray for the MMPL-PAMB's attention for this project is much needed by the ICC CAMPAL in their quest of poverty alleviation.




