FORFEITURE AND DISPOSITION

Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated November 18, 2022 relative the above subject.

Per memorandum, the recovery/apprehension was made on September 20, 2022 at around 12:08 A.M. by the enforcement personnel of CENRO Taytay and personnel from Taytay Municipal Police Station while doing verification, surveillance and patrolling activities and found the piled of lumbers of Pidong-pidong tree species in the area of Sitio Culanga, Barangay Poblacion, Taytay, Palawan. No one seen with actual possession of the lumbers within the vicinity during the recovery. Hence, the team concluded that the lumbers were abandoned.

The team apprehended the eighteen (18) pieces (116 board feet) lumbers of Pidongpidong species with estimated fair market value of Php3,480.00. The subject abandoned lumbers were brought and deposited at Forest Products Monitoring Station (FPMS) I at Barangay Poblacion, Taytay, Palawan for safekeeping purposes under the custody of Administrative Aide VI/CENRO Property Custodian Norie D. Pineda.

Notices to the public (Pabatid sa Publiko) dated October 4, 2022, October 11, 2022 and October 18, 2022 were posted to different public places pursuant to DAO 1997-32. In spite of the three (3) consecutive notices posted on different conspicuous places, no claimant appeared before the CENR Office. Hence, absence of the owner/claimant to appear/claim shall be deemed a waiver of their rights to the apprehended item in favor of the government. Further, the notice of hearing dated October 25, 2022 was sent to all concerned parties and finally on November 11, 2022 the administrative hearing was conducted at DENR CENRO Taytay, Palawan.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended forest product (lumbers of Pidong-pidong species) in favor of the government.

**DISPOSITION** 

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

#### WHAT

This is the final report on the administrative adjudication of the eighteen (18) pieces of lumber of Pidong-pidong species equivalent to one hundred sixteen (116) board feet.

#### WHEN

The interception/recovery took place last September 20, 2022 and the corresponding report was submitted and received in the Office on September 20, 2022 (Annex A to  $A_1$ ), geotagged pictures (Annex B), and Apprehension Receipt (Annex C to  $C_2$ ).

### WHERE

The forest products were recovered in So. Culanga, Barangay Poblacion, Taytay, Palawan and brought to Forest Product Monitoring Station (FPMS) I at Poblacion, Taytay, Palawan.

#### **WHO**

The so-called Apprehension Receipts bear no name of probable culprits. The operating enforcers were Forester II Dennis Aldrin O. Velasco, Forest Protection Officer Marlon S. Paulo, Forest Protection Officer Deogracias M. Vasquez Jr, Park Ranger Reynold Ortega and personnel from Taytay Municipal Police Station.

#### WHY

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

#### HOW

The essential portion of the report is quoted as follows:

".....conducting regular patrol and surveillance on September 19, 2022 8:00 o'clock in the evening from Sitio Nagtacayan to Sitio Culanga, The undersigned were able to chance upon two (2) topdown motorcycles loaded with unidentified lumber while conducting patrol at around 10:45 pm. within the vicinity of Sitio Culanga. A hot pursuit was then entailed until the two (2)

topdown entered a dirt road just before the Taytay Marines Detachment. The undersigned then requested assistance from Forester Velasco, Park Ranger Ortega and Forest Ranger Sanchez due to the area being known as haven for illegal doers. The undersigned also requested assistance from Taytay MPS personnel.

The undersigned were able to come across an empty topdown already parked and covered in leaves while searching the area. They were also able to uncover the undocumented lumber scattered on the side of the road a few meters away from the parked topdown.

Further inquiry with the people who appeared in the area alleged the owner of the topdown and apprehended lumber to be one Mr. Eric Barbon, also present in the area while inquiring about the ownership of the top down and lumber was one Mr. Ronnie Barbon who insisted that the owner of the said lumber was his uncle Eric Barbon though Ronnie Barbon appeared to be drunk and intoxicated with alcohol. Eric Barbon also appeared on site but denied ownership of the apprehended lumber.

The undocumented forest products were apprehended at 12:08 am, September 20, 2022 and brought by the undersigned to FPMS 1, Taytay, Palawan for safekeeping."

#### ADJUDICATION PROCEDURE

Seizure Receipt (Annex D) and Seizure Order (Annex E to  $E_2$ ) were facilitated on October 4, 2022 in order to acquire jurisdiction over the intercepted items. The seized items have an estimated value of three thousand four hundred eighty (3,480.00) pesos. Public notices (Pabatid sa Publiko) were posted consecutively every week on October 4, 11 and 18, 2022 (Annexes F to  $F_2$ ). The Certification of the Records Officer dated October 25, 2022 was then issued upon completion of the posting of Pabatid to the Public (Annex G).

In the absence of claimant, the undersigned opted to adjudicate the issue on the basis of the report submitted. This Office sent invitation to Forest Protection Officers Marlon S. Paulo and Deogracias M. Vasquez Jr. and Punong Barangay Maria Lucia R. Rodriguez of Barangay Poblacion, Taytay, Palawan to a hearing on  $11^h$  day of November, 2022 at 3:30 in the afternoon (Annex H to  $H_1$ ).

The examination pushed through as evidenced by the Attendance Sheet (Annex I). Preliminaries such as attendance check and the IEC presentation was set aside since all of the attendees were personnel from this Office.

On the examination, *Hearing Officer* directly asked the Apprehending Team on how did the information about the lumber came to their knowledge. *FPO Vasquez* replied that they noticed that the topdown loaded with lumber passed by and they followed it until the Culanga area. *HO* asked on the identity on the owner of the topdown and *FPO Vasquez* mentioned certain Mr. Ronie Barbon and Eric Barbon. *HO* continued the inquiry on the next step done by the Apprehending Officer and the location of the lumber. *FPO Vasquez* replied that they hauled the lumber and brought to the FPMS I, Rotonda, Poblacion, Taytay, Palawan. *HO* then asked about posting of pabatid and *AAVI Dela Rosa* answered "yes". Without further clarifications, *HO* then adjourned the hearing.

Transcript of the minutes is Annex J to  $J_1$ .

#### CONCLUSION AND RECOMMENDATION

The items listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus hereby recommended for the issuance of Order of Forfeiture. Further, the names mentioned (Eric Barbon and Mr. Ronnie Barbon) during the administrative hearing is just a mere hearsay hence the undersigned recommended to put them in the watch list of this Office.

#### WHAT

This is the report of the apprehended of eighteen (18) pieces of pidong-pidong lumber with different dimensions with corresponding volume of 116 board feet.

#### WHEN

The apprehension was done on September 20, 2022 at 12:08 o'clock midnight and the corresponding report was submitted and received in the Office on September 20, 2022 along with the geo-tagged photos and Apprehension Receipt with Tally sheet.

#### WHERE

The apprehension took place at Sitio Culanga, of Barangay Poblacion, Taytay Palawan undocumented forest product was also brought by the undersigned to FPMS 1, Taytay, Palawan for safekeeping.

#### **WHO**

There was no probable offender to the said area, and the enforcement personnel apprehended eighteen (18) pieces of pidong-pidong lumber with different dimensions. Apprehending officers were Forest Protection Officers Marlon S. Paulo and Deogracias M. Vazquez Jr. assisted by Forester II Dennis Aldrin O.
