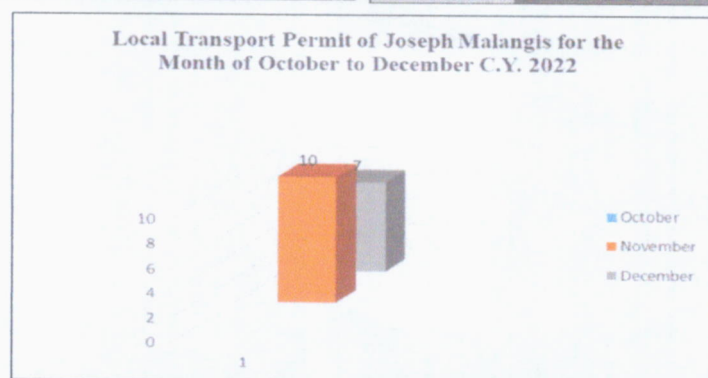

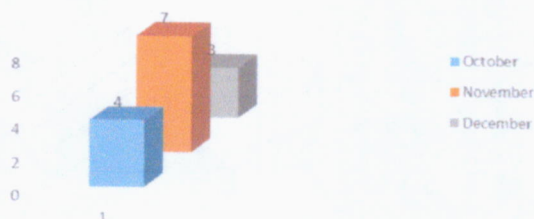

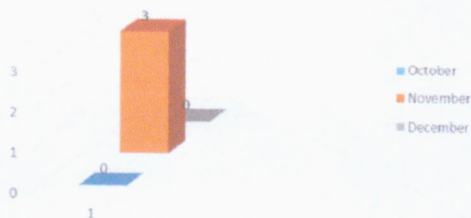

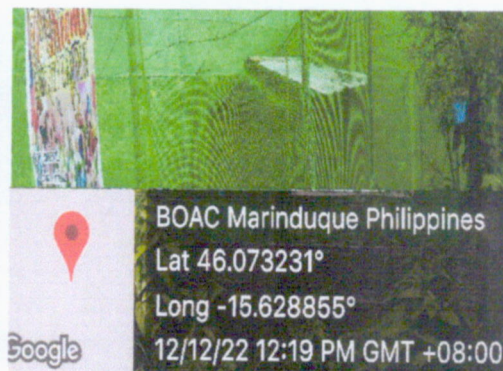

Based on our monitoring of butterfly farm from October to December 2022, there are fourteen (14) registered permittees existing in the Province of Marinduque. Only twelve (12) are regularly transacting their business permit at this Office for the issuance of Local Transport Permit (LTP) while Mrs. Nerisa L. Laylay and Ms. Mary Jane Merencillo – Espiritu have no transaction due to no demand for their clients from other country.

The proprietor's representatives as well as their sub-breeders and breeding stock collector's/trappers were also interviewed to thresh out issues and problems encountered, if any concerning their business operations. They were advised to plant more host plant and to religiously adhere with the terms and conditions of their respective permits (WCP/WFP).


The regular monitoring activities include review and evaluation of their compliance to the terms and conditions of the permit (WFP) such as the release of 10% of the production of butterflies and submission of monthly report.


Per inspection/monitoring it shows that most of the permittees were able to properly manage and maintained their farms and nurseries, except for those who seldom transact business and to those who ceased to engage in butterfly farming and trading.

Those permittees who were not able to properly maintain their farms were advised to strictly adhere to the terms and condition of the WFP including the submission of monthly production report and the 10% release out of the total monthly production.
