In every lecture that we conduct, we always emphasize that the protection and conservation of the environment is not only the responsibility of a sole agency but a collective effort of every member of the community, different agencies and civil organizations. In the lecture and exhibit that we conducted in Sablayan, Occidental Mindoro, this is the message that we want to instill in the minds of our participants as well.

The Lecture on the Ecological Solid Waste Management Act of 2000 was conducted at Occidental Mindoro State College in Sablayan.

Mr. Jaylan C. Nocon and Mr. Li-Feng Nuñez from the Environment Management Bureau led the lecture. They introduced Republic Act 9003 and discussed with the students how it is being implemented in the province. They gave examples of actual scenarios of how people directly and indirectly violate the solid waste management policies. They also presented alternatives and practices to reduce the plastic wastes that are being used by students.

In the end, the students were left with a challenge to start any environment related activity within their school. Since the month of December is also the National Volunteerism Month, they were encouraged to be a volunteer for the environment.

As one of the students said, "The responsibility of taking care of the environment does not depend on the course that a student is taking and everyone must be involved in it."

An exhibit on Marine Protected Area and Digital Paintings was also installed in the school for the appreciation of the students and remind them of the beauty of nature that we tend to forget.
