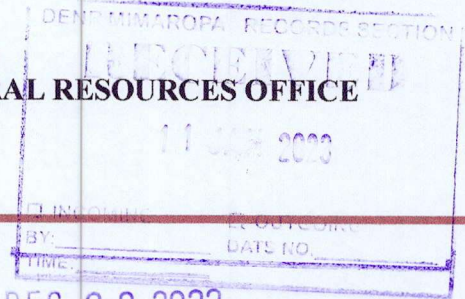

Relative thereto, please be informed that a team from the Land Management Bureau (LMB) was constituted on November 28, 2019 to conduct an investigation regarding the allegations of Ms. Oriondo on the issuance of patents in favor of individuals covering portions of a parcel of land claimed by her grandfather Pedro Eniega. Sometime in April 2022, the team from LMB conducted the investigation on the assailed patents and directly coordinated with the complainant.

In this regard, we concur with the recommendation of the concerned CENRO that the matter be referred to LMB for the status of the investigation.



Sometime in April, 2022, the team from the office of the LMB conducted an investigation in this office and directly coordinated with Ms. Oriondo regarding her allegations.


In this regard, it is hereby recommended that this matter be referred to the office of the LMB for the status of their investigation.

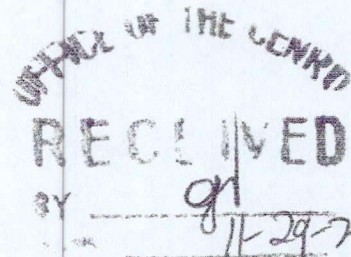
