

The full operation of said facility will start in 2023, thus the funding of the proposed activities is essential for the management and sustainability of the facility:

- 1. Fund/allocation for hiring of personnel under Contract of Service (COS) for the operation of Forest Nursery;
- 2. Fund/allocation for the procurement of other materials for nursery operation;
- 3. Fund/allocation for the procurement of Solar Panel and accessories; and
- 4. Fund/allocation for the maintenance of the Established Forest Nursery.

OCCIDENTAL MINDORO

The Forest nursery establishment under ENGP is very essential and highly required in order to support the NGP implementation to achieve the success of its development vision and mission. This year implementation, the Community Environment and Natural Resources (CENRO) of Sablayan has established Forest Nursery as one of the target in Forest and Watershed Sub program specifically under the Enhanced National Greening Program (ENGP) CY 2022 with a budget allotment of Three Hundred Thousand (P 300, 000.00). Out of the total budget allotment thirty six (36) thousand was allotted for the provision of Labor Services and procured by Administration. There are several activities for the establishment of the said nursery such as:

- 1. Hiring of labourer;
- 2. Purchase of Construction materials for Perimeter Fencing;
- 3. Purchase of Materials for the construction of Potting Shed;
- 4. Purchase of Materials for the construction of Sowing and Germination Area; and
- 5. Purchase of Materials for the construction of Rearing and Hardening Shade.

The established forest nursery is located at Sitio Yapang, Brgy. Batong Buhay, Sablayan Occidental Mindoro with 1, 600 square meter of its total area. The condition of the nursery land area was relatively flat with less than 5% slope and it is near with the SWISS project as a water source for the production of seedlings.

The establishment of Forest Nursery was supposedly accomplished during the 3rd quarter but due to some changes on the preparation of documents and the delivery of the supplies and materials the said activity was not accomplished. However, through the initiatives and effort of this office construction of perimeter fencing was accomplished on 3rd quarter while the other activities was completed and accomplished this 4th quarter.

The following are the monitored and completed activities:

1. Constructed Perimeter Fence

Potting Medium Preparation Area: 9m. x 11m = 99.0 sqm.
 Potting Shed: 9m. x 9 m = 81.0 sq m.

3. Potting Shed: $9m. \times 9m = 81.0 \text{ sq.m.}$ 4. Rearing Area: $(15m \times 12m)(2) = 360 \text{ sq.m.}$

4. Rearing Area: (15m.x12m.)(2) = 360 sq.m. w/ 16 seedling beds 5. Hardening Area: (15m.x19m.)(2) = 570 sq.m. w/ 8 seedling beds

Despite the small amount of fund allotted for the construction and establishment of the Nursery, it was completed and accomplished through the initiatives and effort of Personnel of this office.

Based on the Three Hundred Thousand (P300, 000.00) fund allocated, the budget is for the construction and establishment of the Forest Nursery only, therefore it is hereby recommended and requested for funding the following activities to wit;

5. Fund/allocation for hiring of personnel under Contract of Service (COS) for the operation of Forest Nursery;

6. Fund/allocation for the procurement of other materials for nursery operation;

7. Fund/allocation for the procurement of Solar Panel and accessories; and

8. Fund/allocation for the maintenance of the Established Forest Nursery.












Constructed Seedling Bed and Hardening Area






