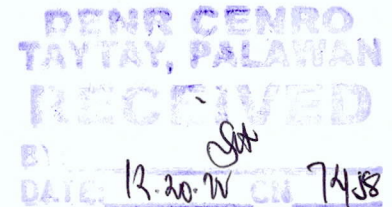

PRODUCERS COOPERATIVE, BARANGAY SAN FERNANDO,
EL NIDO, PALAWAN**



Respectfully submitting is the report on the monitoring of CBFM-CARP 2018 project for the 4th quarter of San Fernando Agroforestry Producers Cooperative (SFAFPC) conducted on December 8, 2022 at Barangay San Fernando, El Nido, Palawan.

The activity disclosed the monitoring of the CBFM-CARP project awarded to the SFAFPC which findings and observations are hereby enumerated as follows:

1. That pursuant to the Executive Order No. 263 adopting Community-Based Forest Management Program (CBFM) as national strategy to ensure the sustainable development of the country's forestland, gave a positive response to address poverty and ensure sustainable management of resources. This was strengthened by the issuance of Executive Order No. 318 known as "Sustainable Forest Management", Executive Order No. 606 known as "Sustainable Upland Development" which anchoring on food, wood and non-wood security and economic productivity. Further enhanced with Executive Order No. 616 known as "The Creation of the Anti-hunger Task Force" to address hunger both on the aspect of supply and demand for food for the upland dwellers, in particular, wherein the San Fernando Agro-forestry Producers Cooperative (SFAFPC) is one of the beneficiaries of the said CBFM program.
2. On November 6, 2001, the DENR awarded the CBFM Agreement to SFAFPC with CBFMA No. RIV-PAL-CBFMA-2001-20 covering an area of 1,378 hectares. The said PO had been a beneficiary of DENR projects particularly the CBFM-CARP 2009 and the National Greening Program and had acquired provisions of tools and materials for the Bamboo Nursery establishment from Pilipinas Shell Foundation.

3. In 2018, the aforesaid PO had acquired the CBFM-CARP project titled "Fuel Wood with Orchard Plantation Project" wherein different commodities had been established in an area of 100 hectares such as Ipil-ipil, Kakawati, Gmelina, Bamboo, Calamansi, Cacao, Coffee, Rambutan, Guyabano, Dragon fruits, Banana intercrop with pineapple, cassava and vegetable crops.
4. That the said PO had completed their project in the last quarter of 2020 including the re-planting activities. However, the monitoring conducted from CY 2021 up to the 2nd quarter of CY 2022 disclosed that some planted commodities were affected by the summer season; not all areas were maintained by the beneficiaries; some commodities had high mortality because they were covered by overgrown weeds.
5. That on August 30, 2022, the CBFM Unit of this Office had conducted a meeting with the beneficiaries to tackle the maintenance and re-planting of their respective plantations and was stressed that there would be a monitoring to be conducted after their said activities had been made.
6. That on the 4th quarter of 2022, some of the PO had conducted replanting activities of Ipil-ipil commodity and clearing of some of their Banana plantations intercropped with Pineapples which were monitored last December 8, 2022. Likewise, other commodities were also visited such as Cacao, Kakawate, Gmelina and Marcotted Calamansi.

During monitoring, the following were observed as follows:

- Replanted Ipil-ipil had high survival rate.
- There were still unmaintained plantations.
- Bananas with fruits were not harvested and eaten by the wildlife.
- There were beneficiaries who did not comply with their commitments to conduct maintenance and replacement of their planted commodities.

In view of the above observations, the following are being recommended, to wit:

- The PO should continue to converse with the beneficiaries and make strategy on how to maintain their plantation areas (ex. seedling production through backyard nursery in preparation for the next rainy season).
- Continue clearing on planted commodities.
- Banana fruits should be harvested.

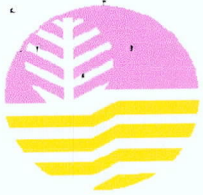

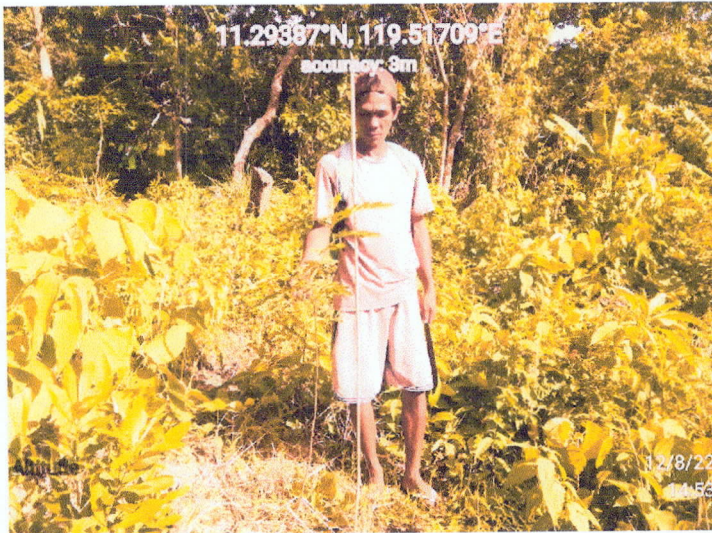

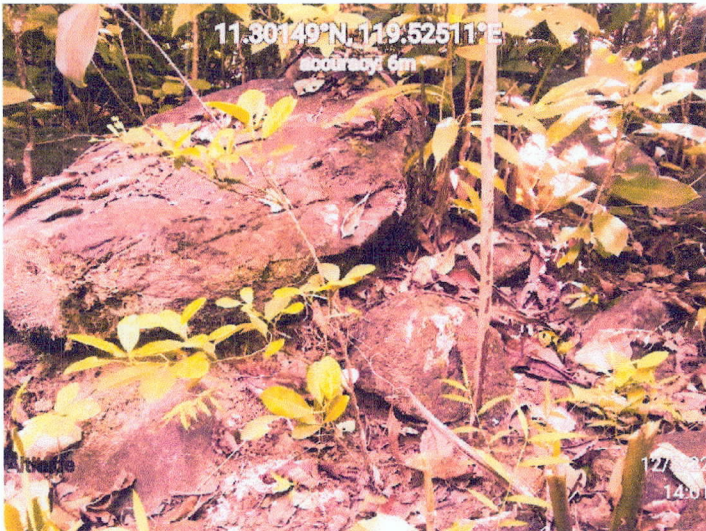
