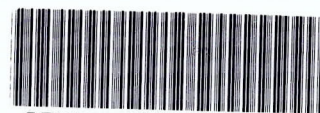

Submitted herewith the report of the deputized WEOs from the Philippine Ports Authority (PPA), Coastguard Station Oriental Mindoro, PNP Maritime Unit 4B and MENRO Puerto Galera. Please be informed that a letter dated November 14, 2022 was sent to their respective offices requesting them to submit their monthly accomplishment report.

Only PPA and Maritime Unit have reply to our letter aside from the constant follow up thru text and call. In the submitted accomplishment of Maritime unit WEOs, they rescued Monitor Lizard and was turned over to PENRO. They also buried 80 marine turtle eggs for hatchling. There were no incidents encountered in relation to violation of wildlife act within the area of responsibility of the PPA.


