





- d. **SUSPEND, CANCEL, REVOKE and DECLARE VOID any and all proceedings being undertaken to any and all applications, processes, survey, transfer and / or other matters relative to Lot 7687 Cad 841-D;**
- e. **And such other actions, processes and equitable reliefs under the premise deemed necessary and proper be undertaken to ensure the protection of rights of the Protestants over Lot 7687 Cad 841-D.**
