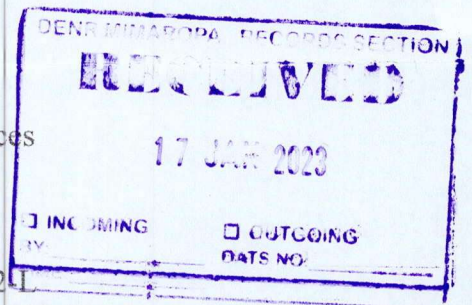


### MANIFESTATION

2. 
