

Respectfully forwarded is the memorandum of CENRO Brooke's Point, Palawan dated December 22, 2022 relative the above subject.

Per memorandum, the recovery/apprehension was made on October 7, 2022 at around 7:50 A.M. by the enforcement personnel of Patrol Base I and Patrol Base III of CENRO Brooke's Point while conducting regular LAWIN Patrol and discovered the stockpile of sacks of charcoal within the mangrove area at Barangay Igang-Igang, Bataraza, Palawan.

The said forest product was discovered and found no claimant or abandoned during the apprehension and same was hauled and deposited at Patrol Base III-Rio Tuba Monitoring Station compound for safekeeping under the custody of Forest Ranger Rudy P. Miraflor. The team apprehended the sixty (60) sacks of wood/mangrove charcoal with estimated fair market value of Php13,200.00.

Notices to the public (Pabatid sa Publiko) dated October 19, 2022, November 2, 2022 and November 14, 2022 were posted to different public places pursuant to DAO 1997-32. In spite of the three (3) consecutive notices posted on different conspicuous places, no claimant appeared before the CENR Office. Hence, absence of the owner/claimant to appear/claim shall be deemed a waiver of their rights to the apprehended item in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended forest product (60 sacks of wood/mangrove charcoal) in favor of the government.



Submitted herewith is the summary of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32.

**I. FACTS OF THE CASE**

The apprehension was made by the DENR CENRO Brooke's Point Patrol Base I and Patrol Base III personnel on October 7, 2022 at around 07:50 AM while conducting regular Lawin patrol and discovered the stockpile of sacks of charcoal along the mangrove area Barangay Igang-Igang, Bataraza, Palawan. The subject forest products were discovered and found no claimant or abandoned during the apprehension and same were hauled and deposited at Patrol Base III – Rio Tuba Monitoring Station compound for safekeeping under the custody of Forest Ranger Rudy P. Miraflor.

**II. NOTICE OF HEARING**

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: Rules for Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 08, Item No. 03, posting of notice to the public for the conduct of administrative hearing for three (3) consecutive weeks was conducted by this Office at the different conspicuous place of Bataraza, Palawan.

**III. EVALUATION**

In spite of the notices posted however, no claimant has appeared on this Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their right to the items apprehended in favor of the government.

**IV. RECOMMENDATION**

In view hereof, it is recommended that the sixty (60) sacks of Mangrove charcoal apprehended at Barangay Igang-Igang, Bataraza, Palawan be forfeited in favor of the government.
