KNOW ALL MEN BY THESE PRESENTS:

Excerpt from the minutes of meeting of the Multi-Sectoral Forest Protection Committee (MFPC) of the Municipalities of Taytay and El Nido, Province of Palawan on its special meeting on this 31st day of August, 2022 at 9:00 o' clock in the morning at DENR CENRO Conference Hall, Barangay Poblacion, Taytay, Palawan.

This amendment to the Multi-Sectoral Forest Committee Resolution No. 1, Series of 2020 **“A RESOLUTION CREATING A MULTI-SECTORAL FOREST PROTECTION COMMITTEE OF THE MUNICIPALITIES OF TAYTAY AND EL NIDO, PROVINCE OF PALAWAN”** is entered into and between the Department of Environment and Natural Resources Offices, Community Environment and Natural Resources Office-Taytay, Palawan referred to herein as the Primary agency responsible for the protection, management and conservation of all natural resources including PD 705 and RA 11038 and Local Government Unit of Taytay and El Nido, Palawan, Armed Forces of the Philippine (AFP), Philippine National Police (PNP) and Palawan Council Sustainable Development (PCSD), Palawan State University (PSU) Taytay, Campus and Central Taytay National High School (CTNHS) referred to herein as Academe; Malampaya Pancol Multi-Purpose Cooperative (MPMPC), San Fernando Agro-Forestry Producers Cooperative (SFAFPC), Bato Multi-Purpose Cooperative (BMPC), Samahan ng Magsasaka at Mangingisda Na Nangangalaga ng Likas-Yaman (SAMAGMANALIYA) referred to herein as Community Based Forest Management People's Organization (CBFM PO).

WITNESSED THAT:

Whereas, the **PARTIES** hereto entered into a **Resolution No. 3 Series of 2022, “AMENDMENT OF THE PARAGRAPH 1 OF RESOLUTION NO. 1, SERIES OF 2020 ON THE CREATION OF MULTI-SECTORAL FOREST PROTECTION SUB-COMMITTEES FOR TAYTAY AND ELNIDO NAMELY TAYTAY MULTI-SECTORAL FOREST PROTECTION SUB-COMMITTEE AND EL NIDO MULTI-SECTORAL FOREST PROTECTION SUB-COMMITTEE”** dated **August 31, 2022** at **DENR-CENRO, Taytay, Palawan**.

Whereas, the sub-committees shall be composed of members based on DAO 95-17 Section 3, including members that have been initially identified by the Committee.

Whereas, the boundary identified for the creation of the subcommittees would be the Omao Bridge located at Bagong Bayan Elnido Palawan. Jurisdiction before the Omao bridge shall be under Taytay Multi sectoral Committee and after the bridge under the El Nido.


Whereas, the creation of sub-committees is necessary to address specific issues for both municipalities.

Whereas, the duties and responsibilities of each member would be defined the same as on MFPC Resolution no.1 Series of 2020.

Be it **RESOLVE**, that this day 31st of AUGUST, 2022 the Multi-Sectoral Forest Protection Sub-committees Taytay MFPC and El Nido MPFC is hereby **created**.
