

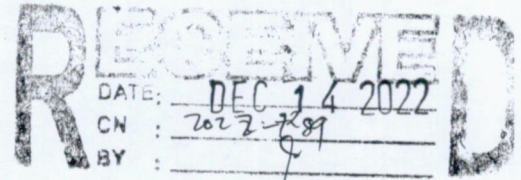

WHEREAS, the Multi-Sectoral Forest Protection Committee (MFPC) approved a resolution entitled: "A RESOLUTION REQUESTING THE SANGGUNIANG BAYAN TO ISSUE A RESOLUTION FOR THE DELISTING OF THE MUNICIPALITY OF BATARAZA FROM THE LIST OF IDENTIFIED ILLEGAL LOGGING HOTSPOT AREAS IN DENR-MIMAROPA REGION"

WHEREAS, this municipality and other partner agencies commit to support the activities to maintain and continue to minimize and neutralize such reported incidents, therefore,


NOW THEREFORE, on motion of Hon. Laurence P. Amores, duly seconded en masse by all members present it was:


