

This pertains to the target activity on the Maintenance and Protection of Coastal and Marine Ecosystem (e.g. reduction of threats and enforcement) - Patrolling under 001 Management of Coastal and Marine Resources/Areas of Malampaya Sound Protected Landscape and Seascape (MSPLS), Taytay-San Vicente, Palawan.

Respectfully forwarded is the memorandum dated December 15, 2022 of Forest Ranger Francis Abe G. Bose et. al. concerning the above subject. Please be informed that this Office conducted seaborne patrol and monitoring within the vicinities of inner Malampaya Sound, during the monitoring the team spotted a three (3) to four (4) motorized boat conducting trawl fishing activity and tried to approached the one (1) motorized boat with green color and without name, however the operator saw them and immediately went to the direction of Sitio Pinagpala, Barangay Alacalian, the chasing incident begun but the boat of the operator is design for racing and the other operators who saw the incident immediately run away and fled.

Likewise, the team identify the two (2) operators namely Mr. Kevin Angeles Estrella, resident of Sitio Pinagpala, Barangay Alacalian operated the motorized boat with green color and owned the recovered the one (1) set of trawl net with board and Mr. Moriel Ramos, resident of Purok San Miguel, Barangay New Guinlo, while the two (2) operators did not identify.

Further, the team recognized the owner of the motorized boat with green color as identify as Mr. Carlo Ramos, resident of Purok San Miguel, Barangay New Guinlo, he was caught in hot pursuit operation during the continuously surveillance and monitoring in the area. The boat was was operated by Mr. Estrella and apprehended in violation of RA 11038, Section (e) and (g) and brought to PAMO-MSPLS together with the one (1) set of trawl net with board for safekeeping purposes.

And on CY 2017, this Office filed a case against Mr. Ramos in violation of RA 8550 as amended by RA 10654, however, the case dismissed.

Moreover, posting of 1st Pabatid sa Publiko dated December 15 and 22, 2022 was served and posted to the concern BLGU and subject for administrative hearing to be schedule on January 2023.

This pertains on the conducted seaborne patrol and monitoring in the above mentioned date and place.

Please be informed that on December 15, 2022 at around 7:40 in the morning, we the undersigned together with Office Support Staff- Richard M. Valones, Richen R. Armenia, Erwin C. Balvin and Data Encoder - Rocky E. Dalabajan departed from Protected Area Management Office (PAMO) at Barangay Old Guinlo, Taytay, Palawan to conduct seaborne patrol and monitoring in the inner part of Malampaya Sound Protected Landscape and Seascape (MSPLS), Taytay, Palawan.

At around 7:50, the team monitored the vicinities of Sitio Maorok-orok and Balimbing, Barangay Alacalian, Taytay, Palawan and there is no illegal activities observed in the area. During the continuous monitoring and surveillance while the team was sailing going to the mid sea of Islang Maliit and Islang Malaki, the team spotted three (3) to four (4) motorized boat conducting trawl fishing operation and tried to approached one (1) of the motorized boat with a green color and without name but the operator saw us and immediately run away into the direction of Sitio Pinagpala, Barangay Alacalian, Taytay, Palawan. The team chased the boat but unfortunately, our boat was no matched in the speed of his boat, meanwhile the other perpetrators who saw the chasing incident immediately run away and managed to escape. Likewise, the team identified the two (2) operators conducting trawl fishing activity namely Mr, Kalvin Angeles Estrella, resident of Sitio Pinagpala, Barangay Alacalian, Taytay, Palawan operated the motorized boat color green and owned the recovered the one (1) set of trawl net with board and Mr. Moriel Ramos, resident of Purok San Miguel, Barangay New Guinlo, Taytay, Palawan however, the other two (2) operators did not identify.

Likewise, at around 8:57 in the morning, the team decided to dock at Islang Maliit to observed and monitor illegal activities in the area. Almost 20 minutes of surveillance, the motorized boat with color green operated by Mr. Estrella that we chased and went to the location of Sitio Pinagpala, Barangay Alacalian, Taytay, Palawan passed through our location, and immediately we decided to chase him going to the location of Purok San Miguel, Barangay New Guinlo, Taytay, Palawan. When the team arrived, the boat was trying to put in the docking area by Mr. Carlo Ramos, resident of the said barangay and the team concluded that during the chasing incident, the operator of the mentioned boat was changed from Mr. Angeles to Mr. Ramos and found out that said boat was owned by Mr. Ramos. The team explained that confiscating of his boat for hot pursuit operation is in violation of R.A. 11038, Section 20 (e) and

(g). Said incident had already a blotter in the Barangay of New Guinlo, Taytay, Palawan as well as in the Municipal Police Station (MPS), Taytay, Palawan.

Further, on 2017, this Office filed a case against Mr. Ramos in violation of R.A. 8550 as amended by R.A. 10654 however, the case was dismissed.

The apprehended motorized boat owned by Mr. Carlo Ramos and one (1) set of trawl net with board owned and operated by Mr. Kalvin Estrella was brought to the Protected Area Management Office (PAMO) at Barangay Old Guinlo, Taytay, Palawan for safekeeping purposes.
