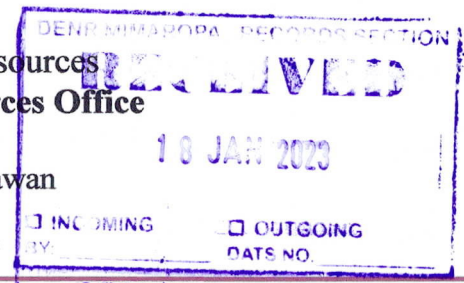



Respectfully forwarded is the memorandum dated December 22, 2022 of CBFM Desk Officer Laarni R. Bolido regarding the above-cited subject.

Please be inform that per report, the two POs awarded with CBFMA's are both active with different activities implemented within their tenured area. The PCMNMP in Sofronio Espanola continuously conducted monitoring and forest protection works within 1,481.25 hectares area. Meanwhile the CBFMA of BMBCB-FMIUFPC in Bataraza also continuously maintaining and protecting the 50 hectares established CARP project awarded to them apart from the protection and management of the 2,092.25 hectares area of CBFMA. Meetings and assemblies were assisted and attended by CENRO personnel.

There are 83 CSC holders evaluated in two (2) municipalities with specific recommendation based on the development introduced and other criteria stated in the guidelines.

Furthermore, this office is continuously providing technical assistance to strengthen the capabilities of the People's Organization and stewardship holders in the development, protection and management of their tenured areas.
