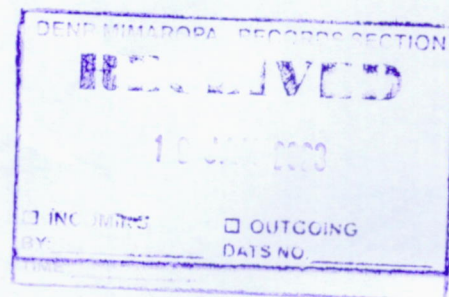



Linear Meters.

The Licensee is authorized to process raw or unworked rattan poles into rattan craft or furniture, the input requirements of which must come from his/her own rattan concession area or from a duly organized cooperative of rattan gatherers/corporations/individuals holding license to cut, gather and transport rattan or a combination of both.

This license is subject to pertinent provision of Presidential Decree No. 705 as amended by Presidential Decree No. 1559 and other applicable laws, including the rules and regulations promulgated thereto and such other regulations which may herein after be prescribed.
