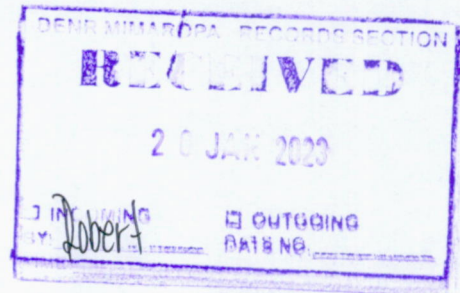



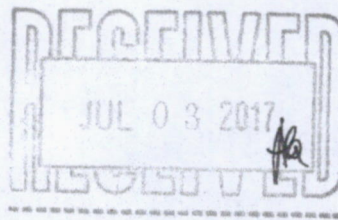
Again, I am humbly asking to give us your immediate attention to this case so we can get settled.




