- 6. Statement of Appropriations, Allotments, Obligations, Disbursements and Balances (FAR No. 1) as of December 31, 2022; and
- 7. Aging of Due and Demandable Obligations (FAR No. 3).

Kindly submit the documents to the FMS-Accounting Division for evaluation and endorsement of the documents.


