QUERY ON DENR CENRO SABLAYAN'S TARGET ON

PUBLIC LAND SURVEY ON C.Y. 2023

This is in connection with DENR CENRO Sablayan's target for Public Land Survey on C.Y. 2023.

Please be informed that until now, the item of Engineer II of CENRO Sablayan hasn't been filled-up. In relation to this, our accomplishment last 2022 had been compromised due to unavailability of a licensed Geodetic Engineer who would focus on achieving our target within the prescribed time. The only Geodetic Engineer in Occidental Mindoro is currently detailed in the PENR Office at Mamburao, Occidental Mindoro holding the item of CENRO San Jose. This office cannot force the said Engineer to expedite the processing of our target since she is not an employee of CENRO Sablayan.

With this, we would like to know if instead of "By administration", can we hire or contract a private Geodetic Engineer to conduct the activity of Public Land Survey? If so, do we need to issue a survey authority or will the existing approved survey order would suffice? What are the requirements that we needed to submit to the Regional Office?

This office would like to avoid repeating what happened last year, that's why we decided to try other means possible in accomplishing the task given to us. Your guidance would be a great help in preventing any administrative problems along the way.
