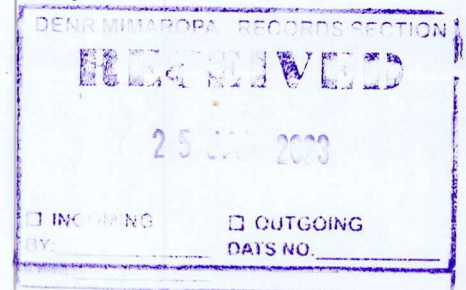

## ORDER

The Manifestation further states that they are still residents of Sitio Asag, Barangay Don Pedro, Mansalay, Oriental Mindoro.


This Office, however, notes that there was no request for a substitution of heirs of Andres M. Gajarion.
