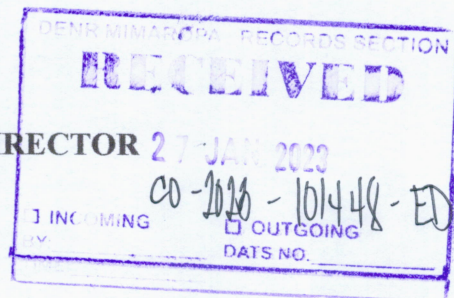



This refers to the attached Memorandum dated 21 December 2022 of the Undersecretary and OIC, Chief of Staff, forwarding the endorsement of Director Jaime Llaguno Mabilin, Presidential Complaint Center regarding the electronic mail of Ms. Imelda Factor Glori, requesting to relocate the Causeway Project in Poblacion, Calatrava, Romblon from the western side of the fish port to its initially proposed eastern portion in order to prevent the destruction of the 100-meter shoreline in the area. Ms. Glori also claims that the said project has various violations including non-consultation to the concerned stakeholders and lack of necessary permits from the DENR.

In this regard, we are referring the matter to your office for immediate appropriate action consistent with existing laws, rules and regulations and to directly inform the party/ies concerned of the action taken regarding this matter, copy furnished this office and the office of the Assistant Secretary for Field Operations – Luzon and Visayas for monitoring purposes.

Expeditious action is requested in accordance with the provisions of Republic Act No. 11032, otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 as implemented and enforced by the Anti-Red Tape Authority. Please be reminded that failure to timely respond to the public's concern shall be a ground for administrative sanctions under existing laws and regulations.
