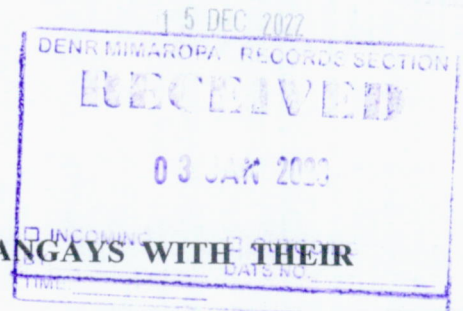

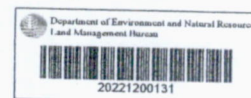


This pertains to the e-mail request of **MR. JEREMAYA R. PAGULAYAN**, dated November 24, 2022, regarding the above-mentioned subject.

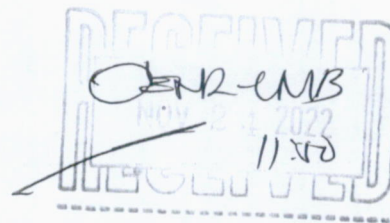
