Submitted herewith is a number of furniture shops ("sash factories") monitored within the area of responsibility of CENRO Socorro. A total of sixty seven (67) furniture shops were visited by the elements of Monitoring and Enforcement Section of this office. During the visit, non-compliance to the requirements of DAO No. 2021-05 "Revised regulations governing the establishment and operations of Wood Processing Plants (WPPs)" were recorded. Hence, they were informed to apply for such permit in the office to avoid any legal consequence thereafter for non-compliance.

Nonetheless, shops owners expressed their sentiments concerning the difficulty in sufficing all the requirements under the said DAO and that they only cater walk in clients with permits. It is important to note, that we too have forwarded a memo dated August 24, 2021 regarding this policy issue.

Attached are the matrix report, monitoring forms, geo-tagged photos and the Memorandum for the RED dated August 24, 2021 as part of usual documentation.

SUBJECT : **QUERY IF SMALL- SCALE FURNITURE SHOP (SASH FACTORY) IS CATEGORIZED AS WOOD PROCESSING PLANT (WPP)**

This pertains to the proliferation of application for registration of small scale furniture shop in this Office. Per review of the related policies we came across with the provisions of DAO 2021-05 or the "*Revised Regulations Governing the Establishment and Operations of Wood Processing Plants (WPPs)*" as the most relevant issuance. However in Section 2 of the same, the definition of the WPP does not entirely covers the small scale furniture shop, specifically on the Daily Rated Capacity (DRC); the dimension and type of machineries used; the volume of wood processed daily; sawmill and re-sawmill, among others.

With regards to source of material for small-scale furniture shop, majority of those who expresses their intent to register stated that their source are from walk-in client with approved cutting permit and from registered plantation covered with CTPO and permit to cut.

In this regard, may we seek advice from the Regional Office to enlighten us regarding this concern.

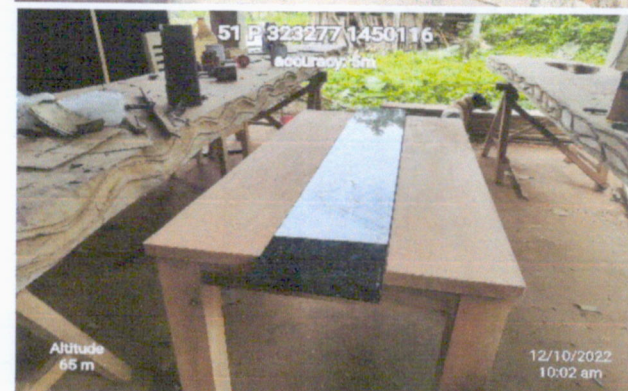
