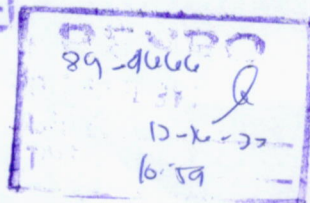
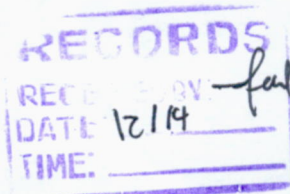


SUBJECT : REQUEST FOR A RE-ASSIGNMENT FROM PENRO
