Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated November 23, 2022 relative the above subject.

Per memorandum, the recovery/apprehension was made on September 7, 2022 at around 9:49 A.M. by the enforcement personnel of Forest Products Monitoring Station (FPMS) II and Forest Protection Officers of FPMS I of CENRO Taytay and ENTMRPA Park Rangers while doing verification, surveillance and patrolling activities and found the piled of lumbers of Ipil tree species in the area of Barangay Aberawan, El Nido, Palawan. No one seen within the vicinity during the recovery. Hence, the team concluded that the lumbers were abandoned.

The team apprehended the fifteen (15) pieces (171 board feet) lumbers of Ipil species with estimated fair market value of Php13,680.00. The subject abandoned lumbers were brought and deposited at Forest Products Monitoring Station II at Bagong Bayan, El Nido, Palawan for safekeeping purposes under the custody of Administrative Aide VI/CENRO Property Custodian Norie D. Pineda.

Notices to the public (Pabatid sa Publiko) dated October 3, 2022, October 10, 2022, and October 17, 2022 were posted to different public places pursuant to DAO 1997-32. In spite of the three (3) consecutive notices posted on different conspicuous places, no claimant appeared before the CENR Office. Hence, absence of the owner/claimant to appear/claim shall be deemed a waiver of their rights to the apprehended item in favor of the government. Further, the notice of hearing dated October 25, 2022 was sent to all concerned parties and finally on November 11, 2022 the administrative hearing was conducted at DENR CENRO Taytay, Palawan.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended forest product in favor of the government.

ISSUANCE OF ORDER OF FORFEITURE AND DISPOSITION

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

WHAT

This is the final report on the administrative adjudication of the fifteen (15) pieces of lumber of Ipil species equivalent to one hundred seventy-one (171) board feet.

WHEN

The interception/recovery took place last September 7, 2022 and the corresponding report was submitted and received in the Office on September 27, 2022 (Annex A to A_1), geo-tagged pictures (Annex B), Map showing the area (Annex C to C_1) and Apprehension Receipt (Annex D to D_2).

WHERE

The forest products were recovered in Barangay Aberawan, El Nido Palawan and brought to Forest Product Monitoring Station (FPMS) II at Bagong Bayan, El Nido, Palawan.

WHO

The so-called Apprehension Receipts bear no name of probable culprits. The operating enforcers were personnel from the Forest Product Monitoring Station (FPMS II) composed of Forest Ranger Jonathan A. Arzaga, Forest Technician II Bienvenido F. Veguilla III, Forest Ranger Herson Y. Caliao, Forest Protection Officers of FPMS I and ENTMRPA Park Rangers.

WHY

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

HOW

On September 7, 2022 at about 9:49 in the morning, the team apprehended the abandoned 171 board feet of Ipil lumber stockpiled at the mentioned barangay. They brought the items to FPMS II, Barangay Bagong Bayan, El Nido, Palawan.

Adjudication procedure

Seizure Receipt (Annex E) and Seizure Order (Annex F to F_2) were facilitated on October 3, 2022 in order to acquire jurisdiction over the intercepted items. The seized items have an estimated value of thirteen thousand six hundred eighty (13,680.00) pesos. Public notices (Pabatid sa Publiko) were posted consecutively every week on October 3, 10 and 17, 2022 (Annexes G to G_2). The Certification of the Records Officer dated October 24, 2022 was then issued upon completion of the posting of Pabatid to the Public (Annex H).

In the absence of claimant, the undersigned opted to adjudicate the issue on the basis of the report submitted. This Office sent invitation to Forest Technician I Voltaire M. Delos Angeles, Forest Technician II Bienvenido F. Veguilla III, Forest Ranger Jonathan A. Arzaga, Forest Ranger Herson Y. Caliao et. al, and Punong Barangay Rodante V. Reynoso of Barangay Aberawan, El Nido, Palawan to a hearing on 11^h day of November, 2022 at 3:00 in the afternoon (Annex I to I₁).

The examination pushed through as evidenced by the Attendance Sheet (Annex J). Preliminaries such as attendance check and the IEC presentation was set aside since all of the attendees were personnel from this Office.

On the examination, *Hearing Officer* directly asked the Apprehending Team on how did the information about the lumber came to their knowledge. *FT II Veguilla* introduced himself being the Team Leader of FPMS II; relayed that on September 7, they received information from a concern citizen about the stockpiled lumber; that upon verification of the FPO, the information was found to be positive, they called for a back-up from other stations and proceeded to the area; that they conducted investigation on the possible owner of the lumber but found none since the area is quite far from the community and that they considered the item as abandoned. *HO* inquired about follow up investigation on the incident and *FT II Veguilla* answered yes but found no claimant. *HO* then inquired about posting of Pabatid sa Publiko and *Administrative Aide VI Dela* Rosa answered "yes". Without further clarifications, *HO* then adjourned the hearing.

Transcript of the minutes is Annex K to K₁.

Conclusion and recommendation

The items listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus hereby recommended for the issuance of Order of Forfeiture.





