BARANGAY III, ROXAS, PALAWAN

Respectfully forwarded is the memorandum of CENRO Roxas, Palawan dated November 25, 2022 relative the above subject.

Per memorandum, the apprehension was made by CENRO MES personnel on June 2, 2020 at around 7:50 A.M. while member of the apprehending team riding a personal motorcycle and saw a topdown loaded with lumbers traversing along Nin-bay Road, Barangay III, Roxas, Palawan. The team intercepted/apprehended the Topdown Tricycle (Kymco 150) loaded with 15 pieces (14 pieces Kurayan lumber & 1-piece Ilang-Ilang lumber) with equivalent volume of 109.32 board feet without permit in violation of Section 77 of PD 705, as amended and have estimated fair market value of Php80,000.00 and Php5,226.00 respectively.

The apprehended conveyance loaded with lumbers were driven and owned by Reuben A. Pacaldo of Barangay Minara, Roxas, Palawan. The apprehended lumbers and the vehicle are now deposited at CENRO Compound, Barangay III, Roxas, Palawan for safekeeping purposes under the custody of Foretser I Marces C. Lasangen. Pursuant to Section 7, Item No. 1 of DAO 1997-32, the notice of hearing dated April 13, 2021 was sent to Reuben A. Pacaldo and the administrative hearing was scheduled on April 22, 2021. However, the hearing was postponed due to COVID 19 strict protocols. Another notice of hearing dated February 7, 2022 was issued for February 16, 2022 hearing, but the respondent failed to appear in the Office. A third notice dated February 18, 2022 was released for March 2, 2022 hearing but again, the respondent failed to attend. A fourth and final notice dated March 2, 2022 was issued and the hearing was conducted on March 9, 2022.

We concur with CENRO recommendation for the issuance of confiscation order for the apprehended conveyance and lumbers.

Submitted herewith is the summary of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32.

#### I. FACTS OF THE CASE

The apprehension was made by the DENR CENRO MES personnel on June 02, 2020 along Nin-bay Road in Barangay III, Roxas, Palawan. Upon investigation, the driver/owner was identified as Mr. Reuben Pacaldo. Further, he was asked to present legal documents pertaining to the loaded forest products in his topdown tricycle but failed to do so. The apprehended forest products and conveyance were brought to this Office compound for safekeeping under the custody of Forester Marces C. Lasangen.

#### II. NOTICE OF HEARING

Pursuant to the provisions of the Department Administrative Order No. 97-32 Re: Rules of Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 07, Item No. 01, a Notice of Hearing dated April 13, 2021 for the conduct of admin proceeding was issued to Mr. Reuben Pacaldo and was scheduled on April 22, 2021, however due to the advisory of Municipality IATF of Roxas to isolate and to avoid group gathering in relation to increasing COVID-19 cases in the Province of Palawan, the scheduled hearing was postponed until further Notice.

Another Notice of Hearing dated February 07, 2022 was issued to the same and was scheduled on February 16, 2022 but the Respondent failed to appear in this Office. A second Notice of Hearing dated February 18, 2022 was issued and was scheduled on March 02, 2022 but again, he failed to attend the Hearing. A third and final Notice of Hearing dated March 2, 2022 was issued and scheduled on March 09, 2022

#### **III.EVALUATION**

The administrative hearing was attended by the Mr. Reuben Pacaldo and Mrs. Antonia J. Facaldo.

During the hearing Mr. Reuben Pacaldo stated that on June 02, 2020 at around 7:50 A.M. he was driving his topdown tricycle loaded with lumbers when they were flagged down by DENR personnel in Barangay III, Roxas, Palawan. He also admitted that he did not have any legal permits/documents pertaining to the legal source of the forest product and for the transport activity.

In the same hearing, Mr. Reuben Pacaldo stated that the said lumber was from the plantation of a certain Mr. Bugoy Baaco at Sitio Marupic, Barangay Magara, Roxas, Palawan and further admitted that he was the one who sliced the logs into lumber and it was scheduled to be delivered to a certain Bobong in Barangay I, Roxas, Palawan.

In summary, slicing/utilizing and transporting of lumber without any permit/documents from this Office is a violation of Section 77 of Presidential Decree No. 77, as amended.

#### IV. RECOMMENDATION

In view of the foregoing, it is therefore recomended that the one (1) unit of Motorcycle Topdown with Engine No. KYRA302106230 and Chassis No. RFGPCKXJ6DB040426 loaded with fifteen (15) pieces of Ilang-ilang and Kurayan lumbers with equivalent volume of 109.32 board feet be forfeited in favor of the government and the institution of the appropriate legal sanction against Mr. Rueben Pacaldo be instituted in the proper court.

Respectfully submitted is the report re: above subject.

Please be informed that at around 7:50 in the morning of 02 June 2020 while the undersigned is riding a personal motorcycle along Nin-bay Road, Barangay 3 of this Municipality, I saw a motorcycle with "sidecar" locally known as "TOPDOWN" (Please see attached photo) loaded with assorted sizes of lumber driven by a man along with a minor child.

The undersigned immediately approached the driver and conducted simple interrogation like asking the driver to present the legal documents of the lumber, species of lumber, source of lumber and where and whom these will be delivered. During the conversation, a certain dodong cannot present any legal documents and also find out that the lumber is a forest species and a naturally grown trees or locally known as "Kurayan" or "Batino" as its common name and Ilangilang. The undersigned immediately intercepted certain Reuben Pacaldo along with the illegal forest products loaded in his "topdown" and called the back-up (Forest Rangers Marco Angelo Marquez, Alonso Tabangay and Forest Technicians Roy Mercader and Nolly Billones) to guide the suspect to our Office for the conduct of scaling and other documentations.

Further be informed, that the apprehended illegal forest products loaded in a topdown is with a total of 15 pieces with corresponding volume of 109.32 board feet. (Please see attached apprehension receipt).

The undersigned recommended that the apprehended illegal (undocumented) forest products be subjected in accordance with DAO 97-32 and file appropriate cases against the offender in violation of P.D. 705 as amended.




