IRAAN, RIZAL, PALAWAN WITHOUT LEGAL DOCUMENTS**

Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated December 6, 2022 relative the above subject.

Per memorandum, the apprehension was made on October 7, 2022 at around 7:30 P.M. by the personnel of CENRO Quezon Quick Response Team and Members of Naval Intelligence Security Group (NISG) while responding to the intelligence report that resulted to the apprehension of two (2) units of motorcycle with sidecar (topdown) and 24 pieces lumbers of Mararango species with a total volume of 332.82 board feet at Sitio Sinuwakan, Barangay Iraan, Rizal, Palawan. The estimated fair market value of the two (2) topdown is Php100,000.00 or Php50,000.00 each and the 24 pieces lumbers of Mararango is Php16,650.00 respectively. The perpetrators (drivers and owners of the subject topdown) were identified as Jolane C. Gaitera, Sr. and Ancel Tawtawan, both residents of Brgy. Iraan, Rizal, Palawan. The transport of Mararango lumbers without pertinent permits from DENR is a violation of Section 77 Presidential Decree No. 705, as amended.

The apprehended items were hauled and deposited at MEMRO Rizal Office located at Barangay Punta Baja, Rizal, Palawan under the custody of Forest Ranger Francisco Escala for safekeeping purposes. The notice of hearing dated October 11, 2022 was sent to all concerned parties in relation to DAO 1997-32. The administrative hearings were conducted on October 19, 2022 and October 28, 2022 at DENR CENRO Quezon, Palawan.

We concur with the CENRO recommendation for the issuance of confiscation order and order of finality of the apprehended conveyance and forest product in favor of the government and filing of appropriate charges against the said violators.



**SUBJECT :** **MINUTES OF ADMINISTRATIVE HEARING ON THE APPREHENSION AND SEIZURE OF TWO (2) UNITS OF MOTORCYCLE WITH SIDECAR (TOPDOWN) AND 24 PIECES OF MARARANGO LUMBERS WITH A TOTAL VOLUME OF 332.82 BOARD FEET AT SITIO SINUWAKAN, BRGY IRAAN, RIZAL, PALAWAN**



Submitted herewith the minutes of the Administrative Confiscation Proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32. The hearing was conducted on October 19, 2022 and October 28, 2022 at DENR-CENRO Quezon, Palawan, respectively.

Please be informed that prior to the conduct of hearing, a notice of hearing was given to the respondents informing them that they have a privilege to exercise their rights to hire a legal counsel of their own choice pursuant to the provisions of the New Constitution. However, despite the considerable period of time since the notice of hearing was served, this office did not received any notice or motion from the respondents to re-schedule the hearing due to non-hiring of lawyer.

Further informed that during the scheduled date of hearing, the respondents asserted to proceed the hearing even without the assistance of their own legal counsel.

**I. FACTS OF THE CASE:**

**WHAT:** Apprehension and seizure of two (2) units of motorcycle with sidecar (topdown) and 24 of pieces of Mararango lumbers with a total volume of 332.82 board feet.

**WHEN:** On or about 7:30 PM of October 7, 2022

**WHERE:** Sitio Sinuwakan, Brgy. Iraan, Rizal, Palawan

**WHO:** Mr. Jolane C. Gaitera and Mr. Ancel Tawtawan, both are residents of Brgy Iraan, Rizal, Palawan.

**HOW:** On or about 7:30 PM of October 7, 2022 the members of CENRO Quezon Quick Response Team and members of Naval Intelligence Security Group (NISG) responded an intelligence report that resulted to the apprehension of 24 pieces of Mararango lumbers, two (2) units of topdown and two individuals at Sitio Sinuwakan, Brgy Iraan, Rizal.

Due to lack of permit presented by the respondents, the apprehending team declared apprehension. They brought the apprehended items at MENRO Rizal for temporary custody and copy of apprehension receipt was given to the respondents.

## **II. PRESENTATION OF PARTIES CONCERNED (*Apprehending Officers and Respondents*):**

1. During the hearing, the apprehending officers were not present but they were able to submit their "Malayang Sinumpaang Salaysay". Based on the malayang sinumpaang salaysay of Forest Technician II Armando Batayo and Forest Technician I Jesse Cascara, they received an information regarding the sighting of two (2) topdowns transporting lumbers from Sitio Sinuwakan, Iraan, Rizal heading towards south direction along the national highway. Their team immediately proceeded at Sitio Sinuwakan, Brgy Iraan and conducted surveillance and monitoring. They spotted two topdowns heading towards Sitio Sinuwakan, they cautiously followed and there they saw the two topdowns parked beside the piled lumbers. Two individuals were about to put/load the lumbers in their topdowns but did not continue when they noticed the presence of the team. The team immediately approached the two individuals and upon securing the area the team introduced their identity.

Per onsite investigation, the two individuals identified themselves as Jolane Gaitera, Sr and Ancel Tawtawan, both are residents of Brgy Iraan, Rizal. Palawan. The suspects disclosed that they had already been on a trip to Barangay Proper of Iraan and the remaining stockpile of lumbers in the area is supposed to be their second trip. When the two suspects were asked of permit or any legal documents of the lumbers, no permit was presented. Immediately, the suspects were informed of their violation and their constitutional rights under Miranda Doctrine.

Subsequently, the team declared arrest and apprehension. Per inventory and scaling, the 24 pieces of Mararango lumbers has a total volume of 332.82 board feet. The apprehended 2 units of topdown and Mararango lumbers were brought to MENRO –Rizal Office for temporary custody and copy of apprehension receipt was given to the suspects.

2. In the same hearing, Mr. Jolane C. Gaitera, recounted that he together with Mr. Ancel Tawtawan both driver and owner of topdown upon arriving in the area where the Mararango lumbers stockpiled, a group of individuals (CENRO Quick Response Team) arrived and accused them for illegal possession of lumbers, they declared apprehension and loaded the lumbers in their topdown and brought to the MENRO Rizal Office.

Mr. Jolane Gaitera stressed that the DENR personnel did not considered the document (*letter request address to Mayor Norman S. Ong hereto attached*) they presented. He explained that he was directly hired by P/B Dominador Pantalita of Brgy Iraan to haul the lumbers at Sitio Sinuwakan, Brgy Iraan, Rizal. Said lumbers will be used in the Brgy

Playground Devices such as Seesaw, Slides and the likes. Later on Mr. Jolane Gaitera admitted that they had already been on a trip of hauling lumbers and he is also the one who invited Mr. Ancel Tawtawan to help him in the hauling of said lumbers.

3. On the other hand, Punong Barangay Dominador Pantalita was present during the hearing, he explained that being a Punong Barangay he should show support for his constituents. P/B Pantalita admitted that they have an on-going project of Playground devices such as seesaw, slides and bookshelves of their Daycare Center. This is in preparation for the upcoming accreditation of Daycare Services of Barangay Iraan. He also admitted that he is the one who hired Mr. Jolane Gaitera for the hauling of lumbers.

Further, P/B Pantalita disclosed that prior to the gathering of wood materials, Barangay Iraan Daycare workers had submitted request to the office of the Mayor to allow them to cut trees and gather lumbers for their project, a copy of which was furnished and duly received by the In-charge of DENR Rizal Station.

Moreover, P/B Pantalita narrated that he had coordinated the matter with Mr. Jayce Mark Delos Angeles, Project Manager-Rizal, Sagip Kalikasan (RSK) in which the later assured him that they can now initiate the cutting and gathering of needed wood materials for their project.

Lastly, P/B Pantalita specified that Mr. Jayce Mark Delos Angeles and members of the Rizal Sagip Kalikasan (RSK) had already inspected and scaled the lumbers before it was hauled. P/B Pantalita said that they have already started the project and some slides and seesaw have already been fixed but they are still lacking for some lumbers to complete the project.

4. Likewise in the same hearing, Mr. Ancel Tawtawan concurred to the statement of Mr. Jolane Gaitera that he was just called to help in the hauling of lumbers.
5. In that hearing, the three Daycare Workers who are among the signatories of the request addressed to Mayor Norman S. Ong and the ones who delivered the request letter are also present. The three (3) Daycare workers (Roby S. Bacay, Team leader, Mea Clear C. Espanol, Asst. TL and Nimfa A. Escala, Bus. Mngr.) said that the letter was received by the Rizal Sagip Kalikasan (RSK) and copies of which were furnished to the office of the MENRO Rizal and DENR Rizal station. They said that Mr. Michael Joven, In-Charge of DENR Rizal Station duly received the copy of request letter. Further, they said that they also personally talked with Mr. Jayce Mark Delos Angeles and they were informed that Mayor Norman Ong has agreed to their request so he is giving them permission to initiate the gathering of wood materials.

Finally, P/B Pantalita, the two suspects and the Daycare workers all said that they would not have dared to do the gathering of wood materials if they were not allowed by the concerned individuals/offices.

6. Further, in the same hearing, Mr. Mark Jayce Delos Angeles, Program Manager of Rizal Sagip Kalikasan (RSK) denied all the statements mentioning the permission "go signal" he gave for the gathering of lumbers. Mr. Delos Angeles admitted that he had read the request and he advised the daycare workers to direct their request to DENR CENRO for the apprehended abandoned lumbers.

Mr. Delos Angeles narrated that P/B Pantalita called him thru mobile phone informing him that they have already gathered lumbers for their project, he responded P/B Pantalita and said that the lumbers were already reported to him by his men (RSK). But he advised his men to just leave it and do not apprehend as it might be the lumbers of P/B Panatlita for his project. In addition, his men are not deputized to do so. In the end, Mr. Delos Angeles repeated and emphasized that he did not give permission or go signal for the cutting of trees and gathering of lumbers.

7. Lastly, in that hearing, ECOMS II Michael Joven, In-Charge, DENR Rizal Station also denied the allegation of the three daycare workers that he allowed or gave permission for them to initiate the cutting of trees and gathering of lumbers. ECOMS II Joven admitted that he received a copy furnish of request letter address to Mayor Norman Ong of Rizal, Palawan, but he explained that he cannot assure if CENRO Quezon grant their request. The three daycare workers informed him that they have already informed the Office of the Mayor, the Rizal Sagip Kalikasan (RSK) and the PNP but ECOMS II Joven insisted to them that only the DENR has the authority of granting a permit for cutting of trees and gathering/transport of lumbers.

### III. APPLICABLE LAWS AND POLICIES:

1. *Section 77 of PD 705 as amended or Revised Forestry Code of the Philippines* " Cutting, Gathering and/or collecting Timber or other Forest Products Without License- any person who shall cut, gather, collect, remove timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code; Provided, that in the case of partnerships, associations, or corporations, the officers who ordered the cutting, gathering, collection or possession shall be liable, and if such officers are aliens, they shall, in addition to the penalty, be deported without further proceedings on the part of the Commission on Immigration and Deportation.
2. Department Administrative Order No. 97-32 dated 1997 Rules for the Administrative Adjudication of Illegal Forest Products and the Machinery, Equipment, Tools and Conveyances used in the commission of crimes.

### IV. FINDINGS/EVALUATION

1. The possession of 24 pieces of Mararango lumbers having a total volume of 332.82 board feet is not covered by appropriate DENR documents/permit, hence a patent violation of Section 77 of PD 705 as further amended;
2. The accused are also the owners of the two (2) units of topdown apprehended;
3. In view of the above findings and facts presented, it was found that there were sufficient and convincing evidences to support the finding of probable cause to charge **Mr. Jolane C. Gaitera** and **Mr. Ancel Tawantawan** for violation of Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.

4. It was clear that P/B Dominador Pantalita has full knowledge on the cutting and gathering of lumbers, he is the one who planned the request, he coordinated with Rizal Sagip Kalikasan (RSK) and he is also the one who hired the suspects to haul the lumbers.
5. Though, Mr. Mark Jayce Delos Angeles strongly denied the allegation of P/B Dominador Pantalita and the three daycare workers, however, he disclosed that his men (members of RSK) had seen the lumbers and it was reported to him but he advised his men not to apprehend as it might be the lumbers of P/B Pantalita intended for playground devices project.
6. The copy of letter request address to Mayor Norman Ong received by ECOMS II Michael Joven was not endorsed/submitted to the office of the CENRO.

**V. RECOMMENDATION**

1. In view of the above findings and evaluation, it is recommended that the 24 pieces of Mararango lumbers having a total volume of 332.82 board feet and two (2) units of topdwon be confiscated in favor of the government in addition to the filling of case against the above –mentioned offender for violation of Section 77 of PD 705 as further amended by E.O. 277.
2. The legal division/office is requested to give advice and further instruction on the part of P/B Dominador Pantalita and Mark Jayce Delos Angeles.

Iraan, Rizal, Palawan kasama ang Quick Response Team ng CENRO Quezon, Special Boat Unit (SBU) 2<sup>nd</sup> Special Operation Unit-Maritime Group at Naval Intelligence and Security Group (NISG) ay nagsagawa ng pinagsamang operasyon hingil sa ipinarating na impormasyon may kaugnayan sa namataang dalawang topdown na nagbibiyaha ng mga nilagaring kahoy galing sa Sitio Sinuwakan. Agad silang nagsagawa ng surveillance at monitoring at nang makita nila na pumasok ang dalawang topdown sa nasabing lugar, agad nila itong sinundan at nang sila ay makarating sa So. Sinuwakan ay nakita nila ang dalawang topdown katabi ng mga nakatambak na nilagaring kahoy, kung saan ang dalawang lalaki ay magkakarga na sana ng kahoy sa topdown pero hindi nila tinuloy noong napansin nila ang parating na team ng DENR. Agad nilang sinabihan ang dalawang tao na wag kumilos ng masama at nagpakilala ang team na mga empleyado ng DENR na nag sasagawa ng operation. Batay sa kanilang pagtatanong nakilala ang dalawang tao na sina Mr. Jolane C. Hereunder are the details of the apprehension conducted:

**1. Apprehension:**

**2. Apprehending Team:**

- a. Members of CENRO Quezon Quick Response Team (QRT)

**3. Circumstances that led to apprehension:**

On the evening of October 7, 2022, CENRO Quezon Quick Response Team received an intelligence report that two (2) units of motorcycle with sidecar (topdown) were sighted transporting lumbers from So. Sinuwakan, Brgy Iraan, Rizal, Palawan heading towards south direction along the national highway.

Immediately, the CENRO Quezon QRT and members of Naval Intelligence Security Group (NISG) proceeded at Sitio Sinuwakan, Brgy Iraan and conducted surveillance and monitoring. At around 7:30 PM on the same date, the team spotted two topdowns beside a stockpile of lumbers with two persons who are about to load the lumbers in the topdowns but did continue when they noticed the presence of the team. The team immediately approached the two persons and upon securing the area the team introduced their identity.

During on-site investigation, the two persons disclosed that they had already been on a trip to Barangay Proper of Iraan and the remaining stockpile of lumbers in the area is supposed to be their second trip. When the two persons were asked of permit or any legal documents of the lumbers, no permit was presented.

Immediately, the two persons were informed of their violation under Section 77 of PD 705 as amended and their constitutional rights under Miranda Doctrine. Subsequently, the team declares apprehension and brought the lumbers and the two (2) topdowns at the MENRO – Rizal office for safekeeping/temporary custody and copy of apprehension receipt was given to the two (2) suspects.

- a. Mr. Jolane C. Gaitera, a resident of Brgy Iraan, Rizal, Palawan
- b. Mr. Ancel Tawtawan, a resident of Brgy Iraan, Rizal, Palawan
