

Per memorandum, CENRO Puerto Princesa has four (4) holder of tenurial instrument monitored and submitted report for the Calendar Year 2022.



The FLA area issued to Seven Seas Resorts and Leisure, Inc. is of considerate distance from the CENR Office and considering the limited budget provided for this year's monitoring, it is practically impossible to physically monitor the FLA area. This office instead engaged in participatory and collaborative approach in conducting the monitoring taking advantage of the services offered by the technologies. 

Please be informed that per inspection and evaluation conducted over the SIFMA area of Alicia Reyes, Rafael Reyes, Rebecca R. Bautista, Rosa Gracia R. Enriquez, Maximo Magno and Emmanuel Bautista all located at Barangay Babuyan, Puerto Princesa City showed that there were no improvements or developments introduced in the subject tenured areas since the issuance last Year 2000 up to this date. The area was considered abandoned by the SIFMA holders which is gross violation of the terms and conditions of the agreement. The holders are not residents of Puerto Princesa City and Province of Palawan and cannot be contacted in their given address.

In view hereof, we would like to reiterate once again our previous recommendations for the immediate cancellation of the agreements per our Memoranda dated February 17, 2005 and August 1, 2011.
