The Undersecretary returned to the OIC, Regional Director of DENR MIMAROPA Region the application for conversion of the Special Land-Use Permit (SLUP) issued to Puerto Del Sol Palawan, Inc. (PDSPI) to Forest Land-Use Agreement for Tourism (FLAgT) purposes located in Sitio Orbin, Barangay Concepcion, Busuanga, Palawan, covering 5.19 hectares of forest land and informed the latter of the evaluation of FMB with the instruction to facilitate the following:

- 1. PDSPI shall compensate the government with annual rental from September 28, 2010 to September 27, 2017 in the amount of P2,724,750.00;
- PDSPI shall be required to deposit/post performance bond of P778,500.00;

3. The P17,569.44 (OR No. 4890203 dated April 27, 2016) expenditure of PDSPI as payment of annual rental and surcharges will form part of the actual rental consistent with Section 16 of DAO No. 2004-28;

4. All the amount paid by PDSPI as its annual rental (P1,494.00 per year from 2010-2016) including the surcharges paid by the same will be considered to form part of the annual rental/back rental chargeable against PDSPI;

Should a FLAgT be approved in favor of PDSPI, the validity of the FLAgT will be reckoned from the first day after the SLUP expired on September

27, 2007 to September 27, 2032;

Submission of CDMP duly reviewed/deliberated at the Regional Office and endorsed by the Regional Director for approval of the Undersecretary and Chief of Staff;

Copy of Memorandum dated March 15, 2018 of the Undersecretary for Field Operations was secured by Forester Fernando G. Perlas at the DENR Regional Office, upon request of Mr. Ramon Garcia, Manager of PDSPI, which was not referred to the PENRO of Palawan.

In view hereof, PDSPI hired the services of Forester Fernando G. Perlas (Retired PRC 1417) to assist in the preparation of CDMP. Forester Fernando G. Perlas, immediately requested the CENRO Coron for Technical Staff to assist him in data gathering for the preparation of CDMP per his letter dated October 27, 2022. The CENR Officer assigned technical staff and assisted Forester Perlas who finally submitted the CDMP (item 6) on November 7, 2022 with attached certified xeroxed copy of the Sangguniang Bayan Resolution No. 98, series of 2021 adopting the Municipal Tourism Development Plan of the Municipality of Busuanga.

Per record of the CENRO, SLUP Number: No. DENR IV-B-MIMAROPA 09272010-0025 was issued on September 27, 2007, to Puerto Del Sol Palawan Inc. (PDSPI), covering an area of Four point ninety eight (4.98) hectares. The proposed FLAgT project covering 4.98-hectares was reduced to 2.56 hectares when the CENRO Team excluded the easement area as shown in the attached map.

The proposed FLAgT area falls within unclassified public forest per LC Map No. 839, Project 2-A dated December 9, 1959 per Cadastral Survey Lot-250, CAD-1150-D, Busuanga Cadastre. In accordance with DAO 2004-28, as amended by DAO 2009-16, PDSPI applied for the conversion of the Special Land Use Permit into FLAgT (Eco-tourism). A lover of nature, Mr. Michael J. Batchelor and his staff have introduced improvements of 25 units of resort facilities and planted ornamental plants to maintain the vegetation of the area like 20 pieces of 5 year old Coconut Palm and fruit trees such as Kasoy, Jackfruit, and Papaya. PDSPI applied for FLAgT to fully develop the area into an ideal resort tourism area/ecological destination.

The CENRO forwarded the Letter of Forester Perlas per Memorandum dated November 15, 2022. The CDMP which was initially evaluated by the CENRO technical staff, reducing the area from 5.19 hectares to 2.59 hectares after excluding the easement areas, found out to be in accordance with the CDMP guidelines. Also attached was a certified xeroxed copy of the Sangguniang Bayan Resolution No. 98, series of 2021 adopting the Municipal Tourism Development Plan of the Municipality of Busuanga. The proponent will settle with the Regional Office regarding items No. 1-5. The CENRO of Coron had favorably recommended for the approval and issuance of FLAgT to Puerto Del Sol Palawan Inc (PDSPI) with attached revised FLAgT Map and Completed Staff Work (CSW) containing xerox copies of 33 pertinent documents which were already secured and submitted at the Regional Office as required per DAO 2004-28 and DAO 2011-02.

Likewise, the PENRO of Palawan favorably endorsed the FLAgT application and CDMP, after it was deliberated by PENRO Technical Staff, per Memorandum dated December 1, 2022 recommending for the approval of FLAgT by the Regional Executive Director pursuant to DAO 2002-10 dated May 30, 2022. The PENRO Technical Committee recommended that the 512 square meters CORE Zone per PCSD ECAN Map and the very steep slopes will be excluded to the 2.59 hectares be determined by the Regional Office. The PENRO endorsement was released on December 2, 2022 and was received at the DENR MIMAROPA Records Unit on December 5, 2022.

The proponent (PDSPI) is earnestly requesting for an audience with the Regional Executive Director, ARD for Technical Services and the Division Chiefs concerned on January 6, 2023 to settle once and for all with the Regional Office regarding items No. 1-5 of the Memorandum of the Undersecretary.


