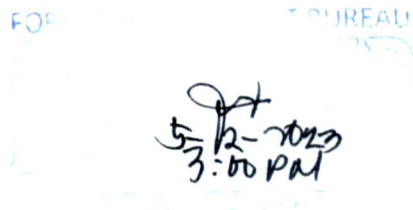

**Dear Secretary Loyzaga:**

Greetings from the 2<sup>nd</sup> District of Palawan!

We propose to plant 300,000 seedlings of Abuyog Sweet Langka. These seedlings originated from Eastern Visayas College of Agriculture in Leyte. We propose to plant in the 2<sup>nd</sup> District of Palawan comprising of 7 municipalities of 120 barangays and each barangay will be allotted 2500 seedlings distributed to 16 hectares per barangay with 8 People's Organization per barangay. One hectare to be planted with 156 Langka seedlings.

We now have 150,000 seedlings, per enclosed pictures, located in various nurseries in Southern Palawan.

We propose to sit down with DENR Greening Program to jumpstart this project as soon as possible.

The project we plant will be geotagged so that any inquiry on where the greening funds went can be answered with photographic evidence.


