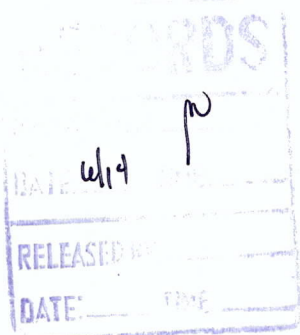



Being the primary agency assigned in protecting the Country's Environment and Natural Resources, patrolling and monitoring are essential to the personnel of Enforcement and Monitoring Section (EMS) of DENR-CENRO Offices. Law Enforcement is necessary to promote the protection of our Environment and Natural Resources.


On May 10, 2023 at around 12:41 in the afternoon, a call was received from Sgt. Freddie Orbestondo Quizon Commo, NCO Bravo 76IB 2ID, Philippine Army regarding the alledged undocumented lumber in Sitio Libagon, Barangay San Agustin, Sablayan, Occidental Mindoro. CENRO Anastacio A. Santos instructed some selected personnel headed by Forest Ranger Cheryll V. Perez, Forest Protection Officers Archy Abris, Angela F. Garlit, Arman Villas, Adrian to go to So. Libagon, Barangay San Agustin, Sablayan, Occidental Mindoro to validate the veracity of the report. The Team proceeded to the area together with Philippine Army Staff and arrived at the location on or about 5:18 in the afternoon. verification the information was true and correct.

On May 10, 2023 at around 9:42 in the evening, joint effort of the DENR-CENRO Sablayan, Philippine Army and Sablayan Municipal Police Station resulted to the arrest of MR. RAYMUNDO LEYÑO, DONATO CASTILLO y KALAMITA, JEROME NENING y GARCIA, JOSE BALDU y CABO and RENE CASTILLO y KALAMITA, 16 years old minor who where caught cutting of two (2) pcs. 2x3x14.5, one (1) pc. 2x3x14.8, one (1) pc. 2x3x14.9 Malugai trees with a total of 29.35 bd.ft., using one (1) unit STIHL chainsaw COLOR ORANGE with serial no. S182450485 without proper documents. The remaining 53 pieces of Malugai lumber with a total of 460.0 bd.ft was brought to Yapang Forest Product Monitoring Station for proper documentation and safekeeping purposes.


The DENR personnel immediately confiscated the illegal forest products and the chainsaw. It was brought to the Office of the Provincial Prosecutor at San Jose, Occidental Mindoro for safekeeping and proper disposition.

On May 12, 2023, the San Jose Regional Trial Court Branch 45 issued the information against of MR. RAYMUNDO LEYÑO, DONATO CASTILLO y KALAMITA, JEROME NENING y GARCIA, JOSE BALDU y CABO and RENE CASTILLO y KALAMITA, 16 years old minor for Violation of Section 68, PD 705 and Violation of Section 7, Paragraph I of RA 9175 docketed as Criminal Case R-11633-23 and R 11632-23. (Chainsaw Act)
