## HIGHLIGHTS

Lionheart Farms (Philippines) Corporation (LFPC) seeks to conserve the remaining forest through protection, reforestation of denuded areas, assisted natural regeneration (ANR) of the remaining forest, and secure the protection and maintenance of planted trees.

#### The Forest Protection project also aims to achieve the following:

- (1) Compliance with the JVA requirements;
- (2) Strengthening existing collaboration(s) with the MENRO, PCSD, DENR, Municipal LGU, and Local Government Units (LGU) of Ransang and Candawaga, Rizal and other local communities and partners primarily with the protection and reforestation of the denuded forest;
- (3) Supporting the National Greening Program of the Government (NGP);
- (4) Further enhancement of the awareness and capabilities of the local communities in the protection, and reforestation of denuded forests and establishment of endemic fruits & trees, and high-value fruit tree plantation;
- (5) Effective mobilization of local communities towards the protection of the remaining forest and establishment of high-value fruit tree plantation; and
- (6) help improve the living conditions of IPs and non-IPs through the promotion of raising indigenous tree and fruit tree seedlings.



# For April 2023, the Lionheart Farms (Philippines) Corporation (LFPC) has accomplished the following activities:

- A. Last April 2023, Lionheart Farms (Philippines) Corporation (LFPC) company continued retaining the forest tree seedlings to maintain seedlings care and maintenance by the process of watering regularly every morning and afternoon during the sunny day and it depends if there is rain, weeding around the seedlings to maintain the cleanliness of the area, spraying organic herbal nutrient (OHN) and fermented fruit juice (FFJ) once a month to provide fertilizer to the seedlings until disposed to the field. Also, at the end of the month, the nursery caretaker conducted an inventory to monitor the number of seedlings. The total seedlings stock in the nursery is Fifteen thousand and two hundred fifty-four (15,254) seedlings. (Please see photos attached as ANNEX A)
- B. Last April 2023, Lionheart Farms (Philippines) Corporation (LFPC) planters team continued conducting plantation care, protection, and maintenance of reforestation area in Sitio Tagbalugo, Barangay, Culasian, Rizal, Palawan. The following activities undertaken are strip brushing, round weeding, alignment and sticking and replanting of seedlings mortality. (*Please see photos attached as ANNEX B*)
- C. Last April 2023, Lionheart Farms (Philippines) Corporation (LFPC) planters team replace the seedlings mortality in Reforestation area at Sitio Tagbalugo, Barangay Culasian, Ransang, Rizal, Palawan. The total seedlings were replanted in reforestation area is five hundred (500) Ipil (Intsia bijuga). (Please see photos attached as ANNEX C)



- D. Last April 2023, Lionheart Farms (Philippines) Corporation (LFPC) the land negotiation team conducted an Information Education Campaign (IEC) in Sitio Maruso, Ogis, Ransang, and Tawa-tawa, Candawaga Rizal, Palawan. The team explained to the participants the proposed bamboo plantation, the advantages of bamboo in the future generation, including the reforestation project, that fights erosion that causes landslides. The activities were participated by the local community of Brgy. Ransang and Candawaga, Rizal, Palawan. (Please see photos attached as ANNEX D)
- E. Last April 2023, Lionheart Farms (Philippines) Corporation (LFPC) Foot Patrol Unit continued conducting the regular monitoring of illegal activities inside JVA and adjacent areas. Based on the report of the Foot Patrol Unit, no illegal activities occurred in the area. The religious conducting Foot Patrol of Lionheart personnel, the intruder was hesitant to do illegal activities such as cutting trees for lumber and poaching of wildlife. 


