

PALAWAN ON MAY 26, 2023.



Please be informed that the program started with a prayer along with the singing of the National Anthem. Afterwards, Welcome Message was delivered by Hon. Barangay Captain Larry Pe greeting the officials of DENR CENRO-Coron and participants from Bintuan National High School students and officials of Barangay and Residence community. On his message he emphasized the importance of preserving and protection of Environment. Barangay Captain Pe also acknowledge and appreciate the initiative of CENR Officer Rodney G. Verian and technical personnel of his office as the lead government agency in safeguarding and management of the environment. After the welcome message of Brgy. Capt. Pe, an Opening Remarks was conveyed by CENR Officer, Forester Rodney G. Verian. He discuss the significance of protecting the forest and other natural resources that relished and useful in everyday life of every individual. He also mentioned that the DENR Coron office will render services and bring the agency closer to the people.

Likewise, the following are the topics discussed, to wit;

- 1. Busuanga Pasture Reserve (BPR) / Yulo King Ranch (YKR)-Manage by DENR-FMB BPRMO under the Presidential Proclamation No.1387, S.1975and Lawin Forest and result of the implementation of Lawin Biodiversity Protection System through B+WISER Program (LAWIN) in Barangay Bintuan, Coron, Palawan.
- 2. Philippine Solid Waste Management Act- presented and discuss by DENR- EMB embedded
- 3. Philippine Mining Act and Quarry Permits and application-Presented and discuss by DENR-MGB embedded personnel.
- 4. Lawin Forest and Biodiversity Protection System (LAWIN) and DAO 97-32-Presented and discuss by Mr. Elizalde Segundo (CENRO-Coron).
- 5. Regulation and Permitting Section (RPS)-Processing of Water Permit Application, LTI/s such as FLAG-OLP, FLAG-t, FLGMA, SLUP, SIFMA/s and Land Matter/s, discuss by LMO-II Arnel D. Cabanillas.





- 6. P.D. 705, Sect. 77 & 78, as amended, Hydrological/ Water Cycle and Importance of TREES-discuss with Forest Technician II Darius T. Jagmis
- 7. Mangrove Ecosystem- discuss with Forest Technician I Reniel Oliver Fuentes.

Furthermore, A Question and Answer Medium was added to the activity and was facilitated by DMO-IV, Forester Edwin I. Cac. As for his closing remark, Forester Cac also highlighted the issues of Climate Change and Global Warming that cause Environmental destruction and problem face by the present generation. He also give some lectures and exercises to the High School students regarding the activity conducted by the DENR Coron in there Barangay. Also, Barangay Captain Larry Pe asked some question regarding the excavation and quarrying of small scale activities in their Barangay address to DENR-MGB representative. Finally, the IEC activity program was ended with great hope in protecting the Environment of said Barangay.


