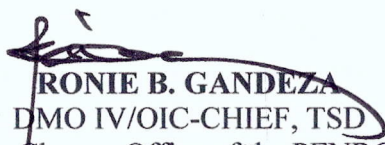

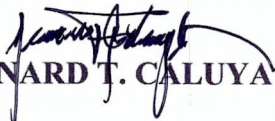

Forwarded/endorsed herewith is the above-subject complaint letter dated June 5, 2023 of Alayma Tambiling Alma seeking assistance concerning the damages/destruction to the livelihood of the Indigenous People in Barangay Maasin, Brooke's Point, Palawan allegedly caused by the mining operation of Ipilan Nickel Corporation (INC).

In the said letter, Ms. Alayma Tambiling Alma conveyed the concerns of the members of the Palaw'an Tribe in Barangay Maasin pertaining to their livelihood, safety and health. Ms. Alma mentioned about them being apprehensive of the widespread flooding, itching of their bodies, dust, rattle and noise generated by vehicles of the company as well as the security personnel shouting/yelling at them. Ms. Alma likewise complained about their loss of source of income/livelihood due to the decline of fish and lobster pry yield including other aquatic plants species in the area since the construction and operation of the causeway/pier of INC.

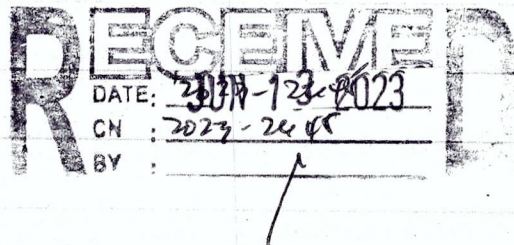
